The witness stated that he wished to explain the fact that on one occasion Dr. McNeill, in traveling from San Francisco to Folsom, he had charged for 330 miles, and he (the witness), in traveling the same distance, had charged only for 200. He accounted for this difference in mileage by saying that he had gone by way of Bantas and returned by way of Benicia, while Dr. McNeill had taken the longer route both ways.

THE CHAIRMAN informed witness that the vouchers showed that both had traveled the same route. Witness said there must be an error in the voucher. Witness was next asked to explain why in one month he had charged the State 20 cents a mile for eleven trips from Oakland to San Francisco, and in another month he had charged the State 20 cents a mile for only one trip.

THE WITNESS replied that committee work in San Francisco was the occasion for these charges. He did business in San Francisco and lived in Oakland. He did not remember what it cost to go to Alameda Springs. He testified that the negotiations for the purchase of the brick lands were conducted by a committee of the Board; did not know at whose instance the Legislature had appropriated \$15,000 for the purchase of the land; did not recollect when the Board entered into a contract for the purchase of the jute machinery.

THE BOARD'S SECRETARY. Jerome Spaulding, Secretary of the Board, was asked to read that part of the minutes which referred to this transaction. The only reference to this transaction which the Secretary could find in the minutes was a motion made by Mr. Everson, and carried by the Board, that it proceed forthwith to contract with the firm of Fairbank, Kennedy & Taylor, of Leeds, England, for the purchase of jute machinery to cost \$60,000.

THE CONTRACT WITH THE WOODS COMPANY. Mr. Everson was next examined with reference to the contract between the State and the Natoma Water Company. He thought the contract was as good as when written. H. P. Livermore had agreed to pay the State fifty cents a day each for the labor of 350 convicts, to be employed on a canal. The only reason that work was not proceeded with was that the improvements of the prison were not complete.

He had written the letter at Mr. Everson's request. He had investigated the matter thoroughly, and found no record in the minutes of any such action of the Board. The statement contained in the letter was an error. Mr. Everson explained that he had merely asked the Secretary to notify Dr. Cary of his appointment by Judge Adams, by the Board.

H. P. Livermore had agreed to pay the State fifty cents a day each for the labor of 350 convicts, to be employed on a canal. The only reason that work was not proceeded with was that the improvements of the prison were not complete.

DR. CARL'S APPOINTMENT. After recess, Jerome Spaulding, Secretary of the Board, was examined with reference to the letter written by him to Dr. Cary, notifying the latter that he had been appointed by the Board Resident Physician of San Quentin Prison. He testified that no action had been taken by the Board justifying him in writing such a letter, and did not remember that he had said, "Elected by the Board." He had written the letter at Mr. Everson's request. He had investigated the matter thoroughly, and found no record in the minutes of any such action of the Board. The statement contained in the letter was an error. Mr. Everson explained that he had merely asked the Secretary to notify Dr. Cary of his appointment by Judge Adams, by the Board.

SECRETARY SPANDLING here read from the minutes the record of the fact that he had been instructed by the Board to notify G. W. Gilkison that it was the desire of the Board that he should proceed to San Quentin and

acquaint himself with the duties as clerk of the Commissary Department. Mr. Everson stated that any action taken by the Board in that case was informal, and should not have appeared in the minutes. The Commission, after requesting Mr. Spaulding to reach the minutes of the Board, and make a memorandum of such portions of the minutes as related to the manufacture of jute, adjourned until to-morrow morning at 10 o'clock.
