The Chinese Bill in the Senate. Blaine continued, with much earnestness: "The English bondholders put up the war on Peru, and it was lost and booty. They make a mistake who suppose that to secure a hearing for Landrean in the Courts in Peru."

WASHINGTON, April 26th.—The debate on the Chinese bill was continued to-day by Slater of Oregon, who sharply criticized Hearst's speech, and contrasted the records of the Democratic and Republican parties on the Chinese question, to the advantage of the latter.

Hawley of Connecticut followed in opposition to the bill, attacking especially the provision against Chinese naturalization and sundry penalty features, which he likened to the machinery of the fugitive slave law.

Edmonds moved to substitute for the fifth section of the bill the following: "That the words 'Chinese laborers,' wherever used in this bill, shall be construed to include persons who are usually engaged in manual labor."
