LOCAL INTELLIGENCE.

BOARD OF CITY TRUSTEES.

The Board of City Trustees met at the new City Hall at 10 A. M. yesterday, all the members present.

Bills were received for the grading and rounding up of Twelfth street, from N to R, but all were rejected on the grounds they were too high.

George Cooper asked for the privilege of using a portion of the city wharf for a fish market. The matter was referred to Trustees Nielsen and the Harbormaster.

A large number of the property owners in the blocks between Third and Fifth, and K and K streets, were present and discussed the Fourth-street assessment.

W. R. Ormsby appeared before the Board and asked permission to give open-air concerts at Plaza and Miller, Frank H. Baker, last session. He also asked that the grounds be better lighted, and that special police protection be guaranteed.

The Board passed the following ordinance: There is hereby levied on each one hundred dollars worth of taxable property in the city of Sacramento...

AN IMPORTANT DECISION.

Relative to the "Credits" of the State Prison Convicts.

Yesterday Judge Armstrong, in Department One of the Superior Court, rendered his decision in the case of John Harris, an habeas corpus, which was brought before him last week. Application of like character had been made to Judge McFarland, of Department Two, previously, and he ordered the prisoner remanded. The petitioner set forth that his term of sentence, of eight years at the Folsom Prison, expired March 20th, and that the Governor had made out his discharge papers and signed them, to take effect at that date.

The Board of State Prison Directors, however, took from him, without allowing him a chance to be heard before the Board, his credits for good conduct, and his discharge had been canceled by the Governor [the credits being signed as a punishment for infraction of the rules by signing letters] and refused to set him at liberty.

Judge Armstrong yesterday did not pass upon the legality of the discharge papers, but upon the question of the credits.
