LEGISLATIVE INVESTIGATIONS.
The McCarty Investigation Resumed by the Assembly Committee.

The special committee of the Assembly, appointed to investigate the charges made against Supreme Court Clerk McCarty...

Grove L. Johnson, counsel for the prosecution, asked if the blotter of the San Francisco office had been brought up.

A. L. Hart, counsel for McCarty, read a dispatch from Deputy Kilsby, saying that the book had not been found...

Mr. Hart said he had heard the book was in the Grand Jury room...

Johnson asked that subpoenas be issued for the Deputy Clerk there, and the Sheriff or District Attorney.

Johnson said the book was a very important one, and that it contained the names of McCarty's handwriting on which many of the charges are based.

Johnson said that he had received a copy of the report for the month, embracing the above transaction, was produced.

Witness testified that it was the usual form of reports made by him, recently by Mr. McCarty, and that he had no conversation with McCarty in reference to the report...
