FATALLY DEFECTIVE.

Representative Morrow Explains the Defects of the Chinese Treaty.

[Copyright, 1888, by the California Associated Press.]

WASHINGTON, April 11th.—At the request of Senator Sherman, Chairman of the Senate Foreign Relations Committee, Representative Morrow has addressed him a letter with reference to the treaty recently concluded between China and the United States. Morrow says the treaty is fatally defective, in not providing in positive terms against the return of a class of Chinese former residents who are not now in the United States but who will certainly continue to be either by proxy, or to assert their claims of right to return. This claim can be made available under the present treaty.

After pointing out the difficulties encountered in enforcing the provisions of the treaty of 1882 and the Restriction Act of 1882, concluded in accordance therewith, Mr. Morrow shows how the law has been evaded. He gives the statistics of the number of Chinese who have come to this country from December 31, 1882, to December 31, 1887, which have been respectively published from figures collected by the Treasury Department, and says that if the treaty only contained the provision in Secretary Bayard's letter—which says that the treaty prohibits the return of Chinese laborers who are not now in this country, and forbids the coming here of Chinese laborers from any quarter—that is, laborers who have been entirely severed—that it would have been entirely satisfactory.

Mr. Morrow says that the most serious complaint made against the present treaty is the clause providing that Chinese laborers who were here at the date of the treaty should be permitted to return to their homes and families, and that it should be plainly admitted that the commonwealth of South Dakota has been injured by the treaty. Turpie obtained the floor, and said that he had laid aside until to-morrow the bill to purchase of the widow of the late General James Shields, certain of the bill to amend the act of February 17, 1871.

The bill for the purchase from Miss Taylor of Taylor Lewis, of a sword of Washington, for \$30,000 was taken up, and read. A long debate ensued, but the matter was over without action, and the Senate adjourned.
