HE GOT IT.

A Red Bluff Rowdy Seeks a Fight and Gets a Severe Dose.

RED BLUFF, April 29th.—This afternoon about 5 o'clock John Mehan stabbed and presumably fatally injured Steve Conroy, a well-known young colored man of this place. The latter, becoming exasperated, drew a pocket-knife and cut Frost's bowels open, permitting them to protrude, and inflicted a serious wound in the groin. Frost was immediately surrounded by a large number of men, and Mehan was taken to Deputy Sheriff Lute Bahney. It is very doubtful if Frost will live until morning.

Irish Nationalists Decline to be Governed by the Vatican.

The Irish Catholics recognize very clearly that churches are not the Church; and, while they will have no objection to the Papal advisers, and especially when no question of faith or morals is involved, they are not prepared to have the authority of the Papacy be directed toward what they are pleased to term the "pacification" of Ireland; in other words, to have the Papal advisers in matters partly spiritual and partly temporal, to be the head of the League. This attempt at spiritual interference in matters partly temporal and partly spiritual, is a violation of the principle of non
