THE INTERNATIONAL MARINE CONFERENCE
in session at Washington, and which has
proved a hard-working and highly-intelligent
body, has surprised the country by
resolving that it is inexpedient at this
time to formulate a system of sound signals
for uniform observance to prevent collisions
at sea. This is a surprise indeed, for the
people had supposed that it was one of the
codes that the Conference would certainly
adopt. The reasons given for refusing to
establish such a code are: The risk of con-
fusion in crowded waters, the false con-
fidence sound signals are likely to inspire,
and the great difficulty of reading and in-
terpreting them correctly. In short the
Conference is of the opinion that it is safer
to trust to the judgment of shipmasters in
each case than to rely upon a code of sig-
nals of uniform application. The Confer-
ence, in a word, is unwilling to become re-
sponsible for any code of sound signals in
the present state of science regarding their
production. When scientific development
gives us a method of giving sound signals
at sea that will insure their correct read-
ing, and will eliminate their deceptive
character, a "sound code" system may be
adopted.

SENATOR STANFORD has promptly intro-
duced a bill providing for adequate
military defense for the Pacific Coast.
The bill proceeds upon the suggestions, sub-
stantially, of General Miles, of the Divi-
sion of the Pacific. The action of the
Senator will have the effect of bringing
the subject so prominently before the pres-
ent Congress, that an official inquiry as to
the real needs of the coast will probably
be made by the Senate, and we may there-
fore anticipate early definite action in
the matter of providing coast defenses,
and that it will be of an affirmative char-
acter. Any impartial inquiry will develop
the fact that the coast, with all its sea-port
wealth, is liable to be laid under tribute
by a single armored cruiser in case of any
international difficulty that may involve a
conflict of arms.

WE have respect for the journalistic
ability of our contemporary, the San Fran-
cisco Alta, who, in his editorial of the 17th
inst., writes editorially of the Citrus Fair.
