Death and Bequests of a Wealthy Man.

We learn from New York papers that Ephraim Holbrook died at his residence, in that city, a few days ago. He was born at Albany. Thirty years ago he became partner and principal manager of the New York branch of the house of Parish, Holbrook & Co., at Charleston.

He had no children, but adopted a little girl as a daughter, who married a Mr. Lee, and went with him to the West. Lee died, and Mrs. Lee went to Connecticut to live. She had a son, to whom Mr. Holbrook bequeathed \$10,000 or \$20,000.

He left a jointure to his wife, and the balance—being about three-fourths of the whole, (three hundred thousand dollars)—he has bequeathed to charitable and religious institutions—the Bible Society, the Tract Society, and several others.

Reputed Autobiography of Washington.

Attention is made to the announcement of the publication in London of a book called "Life of General Washington, written by himself, comprising his memoirs and correspondence as prepared by him for publication; including several letters now first printed. Edited by Rev. C. W. Upham. 2 vols. 8vo." The history of this book is thus given:

"Some years since, Mr. Upham, of Salem, well known for his service to American letters and history, and for his efforts in behalf of the cause of popular education, compiled with care a life of General Washington from his own letters—which was, therefore, in some sense, an autobiography. The holders of copyright in Washington's letters—including, if we are not mistaken, Judge Washington and Dr. Sparks—considered the publication of this book, by Marshe, Capen & Lyon, of Boston, who had permission from them, as an infringement of their copyright. The curious question thus presented was tried before Judge Story, who held that it was an infringement, and granted an injunction against the sale of the book. The plates, thus becoming worthless here, have been sold to the English house in which now reprints them."

Sectional Interests and Conflicts.

The political discussions of the last few years throughout the country and in Congress have included a more distinct recognition of the slavery question as an element of agitation than ever before prevailed, we presume, in the course of our political history.

"I remember well, when a mere child, the contest in 1808, between Madison and Pinkney, and hearing the old people (mere 'fogies') talk of the country being in danger, and I treated in my little shins, the same or very similar words years after, and I inquired then what it meant; and four years after that I laughed at the same expression, and so continued to laugh at the partisan cant from both parties, finding that the country would 'go ahead,' in spite of the election of this or that candidate, until the present occasion. I don't laugh now, for matters look too serious; and I think so chiefly because I believe that both North and South are about to enter upon a struggle for that supremacy which shall secure to the one or the other the direction of the future policy of the country."

THE CAPTURE OF LOPEZ REWARDED.

The Queen gave him \$6,000, and made him a captain in the rural militia, with a salary of \$110 a month; ten negroes and a tract of land have been given to him. ADMISSION. In order to admission to pursue the entire course, a student must be at least fourteen years of age; must give satisfactory evidence of good moral character; and must sustain an examination in the following studies: viz: Arithmetic, Elements of Algebra, Latin and Greek Grammar, Jacob's or Felton's Greek Reader, and the first two books of Xenophon's Anabasis, Jacob's or Doering's Latin Reader, Salustius or Caesar, Select Orations, and Virgil, or what shall be deemed equivalent.
