The Tagalos are a treacherous people and Catholics, while the inhabitants of the southern islands are Moros and Mohammedans. They are a rather pigmy people, very dirty and ignorant and when the Americans first went there would have nothing to do with them and even at the present time will not mix with the soldiers but they do not seem to be afraid of them as formerly. They seem to be a low, sneaking class of people and it is nothing unusual to hear of a cutting across among them. They seem to like the American rule. I guess because the rule does not affect them to any great extent as they have been in the habit of doing as they pleased. They are very indolent and their morality is at the lowest ebb. They will not fight for the Americans or against them. They live in huts scattered all over the island and do very little work. None of them are more than five feet tall and most of them are a little over four feet.

There are very few white people in the southern islands and these are mostly Spaniards and Germans who make a living by trading with the natives. While we were stationed it was about six hundred miles from Manila and the people of that country had never had but very

little communication from the natives of the northern group except through the white people who went from one island to the other. The natives use Arabic characters in writing and their language is very easy to learn, as it has but a very few words and signs.

The only work we did while in the islands was to chase General Rufino and his band for about thirty days and then we did not catch him. He was a rebel general and had with him two deserters from the 4th infantry and they had collected an army of about five hundred people and we chased them all over the island and only succeeded in making prisoners of about fifty. The men would scatter in all directions whenever the soldiers would not very close to them and it was only once in a while that we would see any of the general's army.

The trip home was the best part of the service. We stopped several times and the ship sailed seven times during our trip to this country. We were sixty-two days on the boat. There was an average of about ten men to the company including when we came back to what there were when we first went to the islands, but most of these died from the diseases on the islands and only about twenty-five were killed in battle. In the words of any of the islands it is very unhealthy, but it is a fine country back in the mountains.
