The question was submitted to Judge Gillette for his opinion, but as he was very busy and did not have time to investigate the question he submitted it to Judge Haines, who says he had the identical question before him a few days ago at Pawnee. He holds that section 6, chapter 15 of the session laws of 1897 does not apply to sheriffs, and that the provision of the fees and salaries act applies solely to constables and justices of the peace. Judge Gillette concurs in this view of the law. Therefore, according to the opinion, the sheriff is entitled to the full fee as heretofore collected. The county attorney still insists that his view of the case is the correct one.

and will take the matter into court. The county commissioners still refuse to pay more than the one-half recommended to be paid by the attorney. The same question has recently come up in Garfield county and has there taken form in the suit now being brought against ex-Sheriff C. V. Porter for the recovery of something like \$6,000, alleged to have been collected illegally from the county while Porter served in office. The Garfield county commissioners now in session have instructed the county attorney to bring suit and the papers will be filed within a week. It is a test case based on the interpretation of the law by the present board. County Attorney Sturges explains the situation by saying that a sheriff is not entitled to collect expense incurred by him in serving criminal process within the territory. This ruling is based on the principle that the county is not liable for fees or expenses of any officer, unless the statute expressly provides. In this connection the county attorney holds that no officer is entitled to fees for the county in criminal cases during the trial of the case, but that the county is liable for the same as being tried the counties will be saved several thousand dollars each year.

Judge Gillette concurs in this view of the law. Therefore, according to the opinion, the sheriff is entitled to the full fee as heretofore collected. The county attorney still insists that his view of the case is the correct one.

HANDED DOWN A DECISION.

He Sought to Sell a Relinquishment of His Claim. Guthrie, O. T., Jan. 12.—The territorial school land board handed down a decision today in the Swain-Blandhard case from Bryan, Woods county. This was the case where J. F. Swain, lessee of school land, sought to sell a relinquishment of his land to J. L. Blandhard, cashier of the bank at Byron for \$1,000. The secretary of the board refused to accept the relinquishment and make the transfer because of the protest filed by Jessie L. Swain, wife of J. F. Swain, alleging that her husband sought to transfer the land to the detriment of herself and children in having made no provision for their support, and no longer providing for them. After hearing the case fully, the board sustained the secretary and ordered that no transfer of the land be made until the protest of the wife was waived or dismissed by action of the court, or otherwise, or a relinquishment presented of hearing her signature.

COLLEGE TO BE BUILT.

Only Beneficial Institution in the United States. Shawnee, O. T., Jan. 12.—A \$65,000 college is to be built here. The site has been purchased northwest of the city. It is the eighty-acre allotment of Kishwaukee, an Indian. It is now the property of the Sacred Heart Mission of the Catholic church and cost \$1,000, spot cash. A few weeks ago the Kishwaukee Indian allotment, consisting of eighty acres of land lying just north of the old county fair grounds and west of Kicksapoo street, was sold, but not until yesterday was it definitely known who was the purchaser. This is the only Beneficent institution in the United States. It is operated directly from the headquarters of the order in France.
