SHAFTER TO BE REGIMENTAL POST, ORDERS WAR DEPARTMENT

Coast Artillery Changes Also Directed - Changes Name from Artillery District of Honolulu to 'District of Oahu'

Cabled orders from the Western Division to Colonel McGunagle, now in command of the Department of Hawaii, direct that the two battalions of the Second Infantry now stationed at Schofield Barracks, be moved to Fort Shafter, which becomes a regimental post instead of a battalion post from now on.

This order has been anticipated for the past ten days, the "underground" having been busy with it for some time. Officers of the Second have been discussing the probable change, and opinion is divided as to whether it is good news or bad news.

Just what arrangements are to be made as to the disposition of the troops at Shafter is not decided. This morning Colonel French went to the post to make an inspection, and reach some decision in this matter.

NEW CROP SUGAR SHIPPED TO DATE

According to the records of A. M. Nowell, secretary and manager of the Sugar Factors' Company, 26,900 tons of sugar of the new crop have been shipped up to the first of the year, of which 22,700 tons went by the Tehuantepec route and 4200 tons were sent to the Crockett refinery, San Francisco.

Shipments of the previous crop to the end of December, 1911, amounted to 29,500 tons, of which 24,000 tons was sent to the East by the isthmus and 5500 tons to Crockett. The difference of 26,000 tons in favor of December, 1911, was due to the fact that larger vessels were available than those that started the present season.

this way, the party will be under no obligations to the bosses. "Already fifty thousand dollars a year has been raised for the purpose of carrying on our organization work. Moreover, we have pledged the same amount for a legislative reference bureau which will be established in Washington with experts at the head of it. This bureau will keep in touch not only with what is being done in Congress, but by a fine system with what is being done in every state legislature. We will inform the people what laws are being made, who is behind them, and whether they are good or bad. We will take the whole people into the confidence of the party on the acts of the government. Prof. Charles McCarthy, the noted Wisconsin economist and professor, will be prominent in this bureau."

Asked as to the immediate plans of the Bull Moose party that might affect Hawaii, Mr. Atkinson said that it is too early to say just what will be done here, but that the Bull Moose party in the territory will begin active work on the education campaign.

"Will Roosevelt be a candidate for president in 1916?" he was asked. "It is impossible to say now," said Atkinson. "That depends on the future. However, the principle of presidential primaries that he fought for will be urged by us consistently."

Mr. Atkinson was gratified to learn that the next legislature is expected to pass a direct primary law.

In New York, Atkinson was assistant to the national party treasurer, E. H. Hooker. Atkinson had direct charge of the campaign organization at headquarters. He was also delegated the duty of helping to raise the party campaign funds.

"I never saw such willingness to give," said he. "Men whom I had never met before would give ten, fifteen, twenty-five thousand dollars to the cause after a few minutes' conversation. They gave because it was a

good cause. In our campaign there was no question of political expediency. Right or wrong were the only factors that counted in determining policy."

"The Progressive Party possessed one of the finest organizations that it was ever my good fortune to be affiliated. Our headquarters occupied a floor of the big new Manhattan hotel in New York city. It was the center from which radiated all orders to lieutenants and party workers."

"Hundreds of officials and workers were quartered there. To give an idea of the magnitude of the system employed in the management of the Progressive campaign, it might be mentioned that a corps of thirty trained stenographers were employed to take care of the mass of correspondence."

Mr. Atkinson modestly refrained from referring to his part in the perfected political machine, though he finally admitted that he had to do with the disbursement funds, which seemed to keep the various and multitudinous parts of the Progressive Party machine in the best of working order.

"We had an army of solicitors in every state in the Union," further commented "Jack." "These men were in constant touch with headquarters. We kept posted right up to the second, as regards any move that might be made by the opposing forces."

The returning Bull-Mooseer has nothing but words of warmest praise and commendation for what he terms the wonderful executive ability displayed by George W. Perkins, in his management of the stupendous organization.
