## 'PLAGUE MOVIES' TO BE SHOWN ON HAWAII

The moving pictures depicting conditions which breed tuberculosis have been sent to Hilo where several free exhibitions will be given, stated Dr. A. N. Sinclair this morning. The pictures will be shown in one of the theaters there and all persons will be invited to witness them. The action in sending the pictures to Hilo is in line with the plan of the Anti-Tuberculosis Association, which is to have them shown over the entire islands, as a graphic lesson in the value of sanitation. The "movies" were shown here to crowded houses for several evenings. The success of the exhibition here convinced the local physicians interested in the anti-tuberculosis campaign that the pictures will be a great benefit to the public health. They say that nine cases out of ten of tuberculosis can be traced to ignorance of the laws of sanitation, and it is upon this thesis that they conclude that when the people fully understand how insanitary conditions breed tuberculosis, the annual number of its victims will rapidly decrease, and the white plague will be struck a hard blow.

### ADMINISTRATOR TO SELL PROPERTY OF PFOTENHAUER ESTATE

After hearing the petition of George Roddek, administrator with the will annexed of the estate of W. Pfothenhauer, an order was made in the circuit court this morning permitting two pieces of property, belonging to the estate and situated in Nuuanu valley, to be sold. The estimated value of the property is given as \$25,000.

It is recited in the petition of the administrator that at the time of the death of Mr. Pfothenhauer he had outstanding debts aggregating \$50,000, and that it is now in the best interests of the estate to discharge so much of these debts as possible. The entire estate is valued at \$200,000.

### Hawaii and Craft

"Wash Hawaii's dirty linen on Hawaii" is the keynote of the following article reproduced from the Kohala Midget:

The arrest of Supervisor Kealoha, for alleged false certifying of payrolls, is another step in the uncovering of fraud in the county administration. Whether or no the last accused is proved guilty (we could hope charitably and for the good name of the county he may not be) the charge, and the possibility, yes probability, of similar charges against others, fixes a stigma upon Hawaii county which it will be hard to wipe out. Wherever one travels, in Hawaii or on the coast, we are told, Hawaii county finances are a by-word and a laughing-stock.

"You from Hawaii county? Oh yes, rotten borough; a thief to every square inch!"

What is Hawaii county going to do to cleanse its escutcheon? So far the Hilo Board of Trade, and the territorial probers are doing about all that is being done to get the grafters out of office and into jail. We have not heard of a single civic organization in the county; or a church, or other organization, that has passed a hot resolution, or a single community that has held an indignation meeting.

The policy in some quarters seems to be one of keeping mum. Don't mention the fact that there are county supervisors and other officers in jail, as our district may want something from the board, and what's the use to ruffle their feelings?

We don't believe that the sensibilities of any honest supervisors will be wounded by plain speaking about the dishonest ones. We believe that the county officials whose skirts are clear can justly take no offense if they are reminded that there is too much of a disposition in official circles to coddle official convicts and show maudlin sympathy with stealing public funds.

We believe that public sentiment in Hawaii county is lax and namby-pamby, and that all classes of men need to be aroused to put aside the sordid question:

"What can our district get out of the grab?" and begin to ask seriously the question: "How can we hold up our heads before the world if we do not rise up and wipe out this disgrace?"

If ever there was a time when things must be called by their right names, and the press, the pulpit, the platform and every vehicle of public sentiment must speak out sharply against official rottenness, and not mince matters, that crisis has come in the affairs of Hawaii county.

## PRESIDENT'S DAUGHTER TO WED OBSCURE YOUNG ATTORNEY

WASHINGTON.—The President and Mrs. Wilson announced tonight the engagement of their second daughter, Miss Jessie Woodrow Wilson, to Francis Bowes Sayre of Lancaster, Pa. The wedding is expected to take place next November at the White House. Mr. Sayre is at present an attorney in the office of District Attorney Whitman of New York.

While close friends of both families have known of the engagement for some time, announcement was withheld until today, the first anniversary of Mr. Wilson's nomination at the Baltimore convention.

White House officials accompanied the brief announcement with a biography of Mr. Sayre. He is 28 years old, and, after preparing at the high school at Pottstown, Pa., and Lawrenceville, N. J., graduated from Williams College in 1909. He was manager of the football team there, valedictorian of his class, and interested in Y. M. C. A. work.

He spent two summers with Dr. Wilfred T. Grenfell in his missionary work on the coast of Labrador and studied law at Harvard law school, where he graduated last year "cum laude." He has traveled extensively during his vacations, spending last summer in Alaska and northern Siberia.

Mr. Sayre comes from a collegiate family. His father was the late Robert Haysham Sayre, for a long time president of the board of trustees of Lehigh university, and builder of the Lehigh valley railroad. His mother was Martha Shiley Nevin, a daughter of John Williamson Nevin, theologian and president of Franklin and Marshall college at Lancaster, Pa. She is descended from Hugh Williamson, of

North Carolina, one of the framers of the constitution. She is a sister of Robert J. Nevin, head of the American Church of Rome, Italy, and a first cousin of Ethelbert Nevin, the composer.

While Mr. Sayre is not known to Washingtonians, he has made several quiet visits to the White House in recent months and was a frequent visitor at the Wilson home at Princeton, N. J.

The announcement was received with keen interest in social circles of the national capital, as the wedding starts the winter season, with an important social function. Not since Miss Alice Roosevelt and former Representative Longworth of Ohio were married has there been a wedding at the White House, and many years prior to that the wedding of the Cleverlands took place.

Miss Wilson and Sayre have been visiting the latter's aunt, Miss Blanche Nevin, the sculptress, at her summer home, Windsor Forge, at Churchtown, a few miles from Lancaster, Pa. Miss Wilson has returned to Washington and Sayre to New York.

Sayre has been connected with the district attorney's office in New York for about a year, serving an apprenticeship preparatory to being taken on the regular staff. He is to be added to the prosecutor's list of assistants as soon as he is admitted to the bar, which probably will be this month, Whitman said last night.

"Mr. Sayre is a man of a great deal of ability and I have grown very fond of him in the year he has been working with me. It is a pleasure to me to learn of his engagement to the president's daughter.

### BERT LIGHTFOOT AND BRIDE HOME FROM COAST

J. B. Lightfoot returned from the mainland in the Sierra this morning, a benedict. Accompanying the young attorney was Mrs. Cecilia Moore Haskins-Lightfoot, the couple having been married while Lightfoot was on the coast attending the recent swimming meet.

The Martinez (Cal.) Gazette carried the following article a few days prior to the wedding:

Mrs. Cecilia Moore Haskins, prominent society matron of San Francisco, who is well known in this city where she frequently visits at the home of Mr. and Mrs. J. E. Colton, is soon to become the bride of Joseph B. Lightfoot, an attorney of Honolulu. The marriage license was issued in San Francisco Monday, and after a wedding, which will occur within a few days, the couple will sail for Honolulu, where Lightfoot is practicing.

### SCHOOL MARMs TO BE EXAMINED AUGUST 12

Do you want to be a school teacher and teach young ones everything from manners to the rule of cubic contents? Aspirants for a job as presiding officer of a school room will be given an opportunity next month to take examinations, which, if passed, will entitle them to a certificate with a pink seal on it, by virtue of which they are qualified to "take a school."

The examinations will begin August 12, and they will cover the general grammar and high school courses, with emphasis on English and mathematics. Other subjects will be touched on, including the question of discipline. There will be quite a number of persons taking the examinations, according to notices already received, and they will probably find a school waiting for them. There are now 35 vacancies in the schools of the territory, and the ones who pass the tests will probably get the jobs, which pay on the average of \$72.94 a month.

## MOVIES DRAW WELL AT MASS MEETING OF MEN

What is said to have been the largest mass meeting for men ever held in Honolulu under the auspices of the Young Men's Christian Association, took place in the Empire theatre last evening, when more than 950 men gathered to witness the six-reel photoplay entitled "From the Manger to the Cross."

The meeting was opened at half-past seven o'clock with ensemble singing by the audience, following which David Carey Peters, pastor of the First Christian Church offered the opening prayer. At the end of the first reel of pictures the collection was taken, and following the fourth the association male quartet, composed of Dr. S. D. Barnes, C. H. Tracy, J. G. Hill and George Anderson, sang a number of sacred selections. The films made a deep impression on those who attended the meeting, being especially satisfactory to those who are in the habit of attending church because of the fact that the treatment of the life of Christ is reverent and that there is nothing to offend those who hold His life sacred. The pictures were also very satisfactory from an historical point of view and were free from many of the inaccuracies so often found in religious art. As to the geographical setting, Arthur E. Larimer, who recently returned from a visit to Egypt and Palestine, says:

"The views pictured in the films are exceedingly realistic and I recognized without difficulty many of the places which I visited but a few months ago. The pictures of the pyramids and of the Sphinx by moonlight are especially characteristic. The barren hillsides of Judea, showing the shepherd life, are unusually well portrayed. The streets of Jerusalem, with the camels and donkeys, and the crowds in their native garbs, were very true to life."

### DR. J. S. B. PRATT HANDS REPORT TO GOVERNOR

Dr. J. S. B. Pratt, president of the territorial board of health, returned to his office this morning after a short absence. While away from the office Dr. Pratt completed his report, which he submitted to Governor Freat today. The report gives a clear idea of the large amount of work done by the health department during the period. Dr. Pratt's report is one of the first to be handed to the chief executive. Other department heads are preparing theirs, all of which will be incorporated and issued under the authority of the governor.

The work planned by the board of health for the ensuing year has not as yet been fully outlined, stated Dr. Pratt this morning. He said that he had a great deal planned, but had not had time to definitely develop it yet.
