SHIPPING & WATERFRONT NEWS

BIG FREIGHTERS NOW NEARING PORT

A number of big cargo carriers from opposite points in the Pacific are approaching Honolulu. They are expected to call here in a fortnight.

From the Philippines, China and Japan the steamer Indra, with a shipment of copra, hemp and Oriental freight for the east coast of the United States is expected at Honolulu on February 20.

The first Russian steamer to visit the port in many months is due with the arrival of the Baron Grelsen about February 12.

The heavy losses at sea during the past year, apart from those due to the war, have made 1914 a somewhat bad year for marine underwriters.

HARBOR NOTES

The Pacific Mail steamer Siberia, leaving the mainland for Asia, will call here Friday.

The Matson steamer Hilonian was reported discharging freight at Kahului on Saturday.

Two thousand tons of oriental merchandise will be discharged from the Pacific Mail steamer Manchuria.

The schooner Oceania Vance is reported to have arrived at Port Allen to discharge a cargo of lumber.

The inter-island steamer Mauna Loa will take a large list of passengers to Kona and Kau ports at noon tomorrow.

The Pacific Mail liner Manchuria, expected to depart for the coast tomorrow, will carry the next mail to the mainland.

More than 100 cabin passengers are now booked for San Francisco in the Matson liner Matsonia, to leave at 10 o'clock Wednesday morning.

Included in the freight brought by the steamer Kinau from Kaula was about 7000 sacks of sugar.

About 2000 sacks of Molokai sugar was today discharged from the steamer Mikahala.

With provisions and supplies alleged as destined for Ocean Island, the Japanese steamer Tsurigisan Maru departed Saturday afternoon.

The steamer Claudine, from Maui to Honolulu, met with much rough weather. The vessel has been discharged of a small general cargo.

Bringing a number of military passengers for the various military organizations on Oahu, the United States transport, Thomas from San Francisco is due at Honolulu on Friday.

Delayed by rough weather and the difficulty met in loading sugar, the Matsonia returned to Honolulu from Hilo this morning.

The American-Hawaiian freighter Virginian has completed a voyage from Seattle to Honolulu in a little less than 10 days.

The British steamer Strathgarry was chartered at Portland at the record equal rate of 45 shillings for delivery of grain from that port.

The sinking of the Empress of Ireland hit American underwriters alone to the extent of over \$1,500,000.

The second big loss came when the British steamer Floristan was wrecked on Guleon Island, St. Lawrence, on October 14.
