FRIETH THINKS KAHANAMOKU IS DUE FOR RECORD

Some predictions regarding Duke Kahanamoku are made in a story appearing in the San Francisco Chronicle of March 2. It follows: George D. Frieth, former swimming instructor of the Los Angeles Athletic club, is a visitor in this city and brings some interesting information relative to the performances of the Duke Kahanamoku, who is at present competing at Sydney, Australia. Frieth has handled Duke in numerous occasions and is of the impression that the present world's sprint champion has yet to see his best days. "Without doubt," Frieth states, "Kahanamoku can lower his present world's record for the 100 yards, which is 33.35 seconds. From my intimate acquaintance with Duke, I know that on former occasions he has beaten the best of them practically upon strength, and, with the style which he has now acquired, I look for him to lower his own mark to something in the neighborhood of 32 seconds. Kahanamoku will compete here in the July championships, according to his present plans. It is probable that he will swim under the colors of the Hul Nalu of Honolulu. In a very recent letter from Sydney he states that condition is no cause for worry, and he is ready to demonstrate to the world that he is coming instead of standing still. Another boy who will show here in July is Cliff Bowers, who has held Pacific coast diving championships for the last five years. Bowers is in Honolulu at present, competing in the midwinter carnival under the colors of the Los Angeles Athletic club. He will positively appear here in July, and I look forward to victory for him. Bowers is in a class by himself in the high dive."

Coast Swimming Faster. According to Frieth, the swimming game on the Pacific coast is on the way to steady improvement. Without a doubt he believes the California product will demonstrate its superiority to the world within the next year or so. Our present juvenile generation is material which will be worked into championship timber. Frieth has enjoyed numerous trials in the tank of the Olympic club and is high in praise of its facilities. Frieth's present plans are not yet formulated. It is possible that he may locate in this city, but should he fail to remain here he will undoubtedly return to Honolulu, where he started his swimming career. Frieth formerly held the all-around championships of the Hawaiian Islands, and at present is considered to be one of the best divers in the country. He was presented with a special medal from the United States Congress very recently for his exploits in life saving. It is understood that during his career he has saved some 300 people from drowning.

ELIMINATE LIGHT POLES IN CITY, SAYS HOLLINGER

If the Hawaiian Electric Company is to have its franchise extended to cover the islands of Oahu it should be required to remove its light poles from the streets, using underground conduits for its lines. Such is the opinion of City Supervisor Ben Hollinger, who has written President Chillingworth of the senate on the subject, and who appeared before the senate's judicial committee for the same purpose. Hollinger says he is supported in the demand by the Outdoor Circle and other organizations interested in the growing "city beautiful" movement. There are two measures in the hands of the judiciary committee that affect the electric company. These are S. B. 11 and S. B. 12. One would give the power of eminent domain, to purchase private property by condemnation for rights-of-way or other necessary uses, and the other bill would give it the right to extend its lines and sell "juice" for lighting or power on any part of the island. Hollinger in his letter to President Chillingworth says he is not opposed to the granting of either privilege, but believes it should be conditional upon the removal of the unsightly light poles from the Honolulu business thoroughfares. This is the time, he declares, to extract such a promise from the company. Replacement of poles by underground conduits either has been effected already by nearly all the big municipalities on the mainland or is in process now, he asserts, and Honolulu should follow their example. He suggests that the judiciary committee call another public hearing on these bills for the specific purpose of hearing discussions on this particular question.

"When they have any constructive suggestions to make I shall have something to say. Until then there is nothing." This was the reply made today by F. E. Blake, general manager of the Hawaiian Electric Company, to the long letter sent to President Chillingworth of the senate by Supervisor Hollinger, asking that the extension of the company's franchise be refused unless it removes its poles from downtown streets and installs underground conduits.
