UNNAMED FRIEND ON MAINLAND SENDS CHURCH CHECK FOR \$5000

Bishop Restarick Makes Welcome Announcement at Dinner at University Club

A check for \$5000 from "a friend on the mainland" has been received by Henry Bond Restarick, bishop of Honolulu, for the furtherance of Episcopal church work in the Hawaiian islands. This announcement was made by Bishop Restarick last night at a dinner at the University Club given by the church club of St. Andrews Cathedral to the clergy and delegates to the 13th annual Episcopal convention. The person giving the money requested that the name of the donor not be made public. The donor visited Honolulu not long ago and was taken on a tour of inspection of several Episcopal missions by the bishop. In announcing the receipt of the check, Bishop Restarick said he was always glad to show visitors the work of the church and, while he never asked for money, yet the work has so appealed to many persons who appreciate business enterprise that one man from New York City, who a few years ago was taken on a tour of inspection by the bishop, contributed more than \$20,000 toward the work of the church the year following.

The dinner last night practically closed the convocation. About 50 persons were present. Bishop Restarick was toastmaster, and during the evening called on several members of the clergy and laity for brief remarks. Guy H. Buttolph spoke on the emergency fund for general missions, in which the people of the Episcopal church in the United States are urged to give one day's income or salary toward the support of the missions. F. N. Cockeroff, the new pastor for Lahaina, gave his impressions of the work of the church in Honolulu, laying stress on the earnestness and zeal displayed by clergy and laity. Other speakers were Robert Catton of whose departure the bishop, when introducing him, spoke feelingly; Rev. J. C. Villiers of Walluku, who spoke of the work of the church outside of Honolulu; Rev. J. K. Bodel of Hilo spoke encouragingly of the prospects of the Crescent City work. Rev. F. W. Merrill told of the work at St. Elizabeth's and G. W. R. King of the approaching completion of the new church on Tenth avenue, Kaimuki.

At the close of the dinner a short musical program was given, those taking part being Carlos Caceres, Thomas Carter and John Gifford. Mrs. Restarick entertains. During the affair at the University Club, Mrs. Henry Bond Restarick entertained the wives of the clergy and delegates with a dinner at her residence in Emma square. Many novel schemes engineered by the hostesses made the occasion a delightful one. The guests were obliged to find their places at the table through descriptions placed beside each plate.

THOMPSON WILL BE CANDIDATE FOR CHARTER JOB

Petition blanks for candidates as delegates to the city charter convention have been prepared by City Clerk Kalaaukalanani and are now ready. The election will be held July 6 and candidates must file petitions containing ten signatures before June 26. Just one citizen, however, has been given a petition blank so far. He is William Thompson, who is now on the Coast. He wrote for the blank and it was mailed to him today. Thompson will sign the paper and return it to friends in Honolulu to sign and file for him. He will return in time for a short campaign before the election.

SALVAGE OF ASAMA MAY VIOLATE NEUTRALITY

SAN FRANCISCO, Cal.—Held until he can determine if the proposed trip of the Red Star tug Sea Rover, with two Peterson barges, to aid in the floating of the Japanese warship Asama in Turtle bay, Mexico, is a breach of neutrality. Collector J. O. Davis has ordered the tug and barges to stay in Monterey bay until further orders. The tug, with its tow, steamed from San Francisco and had to put into Monterey bay as one of the barges was leaking.

While in the bay the Japanese cruiser Chitose appeared and entered port, and the tug then left with her, but returned a few hours later. The coast-guard cutter McCulloch was sent to Monterey to watch the Chitose, and now Collector Davis has ordered the entire outfit held until he makes a thorough investigation.

A suit for divorce has been filed in circuit court by Lena Adnakin, the alleged grounds being non-support.

The trial of Frank Kane, charged with assault and battery, is scheduled to begin in Circuit Judge Ashford's court tomorrow.

An inventory of the estate of Samuel Upa, deceased, has been filed in circuit court by Mrs. Kellou Upa, executrix. The estate is valued at about \$2837.48.

At a meeting and luncheon of the Rotary Club at the Commercial Club today, R. H. Trent addressed the members on "Some Functions of a Trust Company."

Charging that the respondent committed a statutory offense, Keizo Morikawa today filed a suit for divorce in circuit court against Suga Morikawa.

Mr. and Mrs. Jos. Schwartz and their daughters, Henrietta and Josephine, arrived on the Matsonia and are stopping at the Moana. They expect to remain in Honolulu for some time.

The regular weekly meeting of the Hawaii Promotion Committee will be held at the Chamber of Commerce rooms tomorrow afternoon at 2 o'clock.

The Mothers' Club of Kaimuki will give a dance to the school children at Liliuokalani school on Friday afternoon of this week from 2:30 to 5 p. m. Children are welcome from other schools.

A. C. Wheeler, acting superintendent of public works, presided at a routine meeting of the harbor commission with the approval of the governor today. Range lights at Kihel, Maui, were discussed.

Concurring with Fire Chief Thurston's plan for gasoline vehicles to replace horse-drawn fire apparatus, the city supervisors have authorized the appropriation of \$1950 for purchase of two Ford cars and one Pope-Hartford roadster for the department.

The case of Solomon Hennessey, charged with furious and heedless driving, is scheduled to go to trial in Circuit Judge Ashford's court at 9 o'clock tomorrow morning.

Three boys, Chinese, Portuguese and Hawaiian, who recently escaped from the boys' industrial school at Waialeale, were captured at Wailua yesterday by Superintendent H. M. Tucker, according to John Anderson, probation officer.

An order was issued by Circuit Judge Stuart today dismissing the case of M. A. Kane against Solomon D. Koki, defendant, and Libby, McNeill & Libby, garnishee, a suit on liquidated demand.

The case of Masuda, a Japanese charged with assault and battery, was nolle prossed by the prosecution in Circuit Judge Ashford's court today as the prosecution was unable to locate the complaining witness.

A. White and five others, charged with being present at a gambling game, today withdrew their appeal of the case from the district court to Circuit Judge Ashford's court.

Alleging non-support, a suit for divorce has been filed in circuit court by Julia Hope Hamakia Nipling, nee Magoon, against Richard Kipling. This makes the 17th divorce suit to be instituted since May 1.

Taxation of plaintiff's bill of costs in the case of Wong Tin Look against Goo Wan Hoy is on the supreme court calendar for tomorrow.

Circuit Judge Whitney has appointed Percy M. Pond administrator of the estate of H. C. Smith, deceased, without bond.

Wall & Dougherty, the local jewelers, have delivered to Helme's Tavern, the new beach hotel, silverware valued at \$4600.

Notice of discontinuance of the assumpsit suit of J. W. Achuck against T. Uratake has been filed in circuit court by the plaintiff.

Sixty-seven teachers in the public schools on Oahu attended a teachers' meeting in the McKinley High School yesterday afternoon. Matters of routine business were discussed and the teachers listened to an interesting address on the educational exhibits at the Panama-Pacific exposition.

Two dozen large alligator pears were received today by Henry W. Kington, superintendent of public instruction, from the teachers and pupils at the Nabiku school. The pears were grown in the school yard.

The department of public instruction has about completed plans for the public school examinations to be held next month. All the examination papers have been made out and will be delivered to the various schools within a few days. There are 52 separate sets of papers.

The funeral services of Artemas Naone, 20 years old, are being held this afternoon from Silva's undertaking establishment, interment to be in Kawaiahaeo cemetery. Naone was an employe of the Inter-Island Steam Navigation Company and was well known in Honolulu.

CURRENT BRINGS GASOLINE DRUMS ACROSS PACIFIC

The mystery of the three drums of gasoline which were fished out of the sea on the Maui coast, bearing the name of the Capitol Refining Company and carrying serial numbers, has been cleared up after considerable correspondence between the manager of Honolulu ranch, Maui; Alexander & Baldwin, Ltd., Fred Waldron, and the San Francisco office of the Shell Company.

The Capitol Refining Company's tank 6429 was shipped on the steamer Rochelle from San Francisco to Portland on July 7, 1913, and was washed overboard from that vessel. Evidently the Japanese current made delivery in Hawaii instead of at the Oregon coast," writes the manager of the Shell Company to Mr. Waldron.

The drums of gasoline were in good shape when salvaged, being scarcely rusted. The gasoline was in full quantity in each drum, and was used by the finders to run the engine in a motor boat.

The containers took 18 months to make the journey from the mainland coast, and were brought solely by the ocean current, for they were practically entirely submerged and could not have caught the winds.
