#### THOUSANDS FLOCK TO HOUSES OF WORSHIP ON THANKSGIVING DAY

Special Praise Meetings Are Feature; Excursions and Picnics Also Popular

Church services, special praise meetings, excursions and private entertainments combined yesterday in making Thanksgiving Day in Honolulu a right joyous and merry occasion. The weather was perfect and thousands of people were out to attend the meetings in the favorite houses of worship. Business in Honolulu was closed, and the occasion was made a real holiday for everyone. Perhaps the most brilliant observation of the day was at the Christian church, where the congregations of that church and the Methodist and Central Union churches gathered for a special service. Dr. Doremus Scudder, Dr. William Henry Fry, David Cary Peters and Rev. L. L. Loofbourow were in charge, the last-named minister delivering the sermon. Music was furnished by a choir composed of singers from the three churches.

Minister Loofbourow's address was entitled "The Seven Sleepers of America," the text being taken from Isaiah 30:21, "These ears shall hear a word behind thee, saying this is the way, walk thee in it." Distinguishing the seven sleepers," the minister said:

"As the seven sleepers of America we might pick out John Harvard and Governor Winthrop of Massachusetts Bay, Roger Williams of Rhode Island, Jonathan Edwards of Connecticut, William Penn of Pennsylvania, Lord Delaware of Virginia, and General Oglethorpe of Georgia. These worthies might constitute a visiting committee from the founders of the United States! Their task would be so vast that we would certainly pardon them for dividing up the work and asking Harvard to report as a sub-committee on our educational system; Delaware and Winthrop on law enforcement; Penn on international relations and arbitration; Oglethorpe on temperance and reforms; and Williams and Edwards on religion and state of the church."

Those who assisted in the entertainment following the dinner were Miss Annetta Dieckman, Miss Evelyn McDougal, Dr. Doremus Scudder, Dr. William Henry Fry and Miss Yoshi Tsuji.

Many Honoluluans entertained friends with dinner at the various cafes, hotels and taverns about the city. At the Coral Gardens, Kaneohe, Host A. L. MacKaye served a tempting Thanksgiving dinner to a large number of guests.

Thanksgiving Day was a gala occasion at Oahu Prison. A huge Thanksgiving dinner—with puna taking the place of turkey—was served at the instance of High Sheriff Jarrett. In the evening an entertainment was held. Governor Pinkham was among the guests during the day. A sport program was carried out in the morning.

#### JUDGE WHITNEY WILL APPOINT AONA AND HITE

Local Men Will Be Made Circuit Court Clerks Despite Objection of Third Jurist

The appointment of Aona will be in the nature of a promotion, he having been second clerk to Judge Whitney for six years prior to the resignation of John Marcellino as first clerk. Aona was a clerk in the supreme court before Judge Whitney appointed him.

Hite, who is from the South, is now with the law firm of Thompson, Millerton & Cathcart. He recently was admitted to practise law in the circuit courts of the territory.
