

# HAWAIIAN SINGERS IN CANOE NOW CHARM DINERS AT NEW YORK CAFE

### Famous Reisenweber's Has Interior Painted With Coconut Trees; Hulas, Too

Score one more bullseye for Hawaiian music as a big attraction for Goldhamites. Hardly had the Swan Song of the Hawaiian musicians been sung in the "Stop, Look and Listen" Company, due to jealousy on the part of Baby Deslys, the star, than Henry Clark, Hawaii's silver throated tenor, and a new company of musicians commenced an engagement at Reisenweber's, the famous cafe on Eighth avenue, New York.

A letter just received from Henry Clark by the Promotion Committee indicates that Reisenweber's has a thoroughly Hawaiian atmosphere. Clark writes that his company is made up of Johnny Kaawa, Jim H. Peterson, Roy Nawahi, Eugene and Berg. He writes:

Reisenweber's has opened one of the biggest novelties in New York city. They have what they call a Hawaiian 400 Club, and believe me, the decorations are beautiful and everything tropical. We played on the boat which makes a tour of the large room, all around which are miniature grass huts, in which are small tables where the guests are served with refreshments. In the center is a large dancing space for the guests. Have Hula Dancer, Too.

The walls are all painted with coconut trees and waterfalls. The ceiling forms a very expansive sky made of blue cloth studded with small stars of electric lights. They have a hula dancer, who by the way, does very fine. The young lady plays the violin beautifully. But the main feature is our boys from Waikiki beach. We are certainly making a wonderful impression. If I had seven other quintets here I could keep them busy as I have been offered more work already than I can handle.

The cafe gives away souvenirs

every night. We have 12 ladies just busy sewing leis and I do the twisting. They intend to give away from 1000 to 5000 every week. Here is one of the biggest opportunities of advertising Hawaii that I know of and you know that I am doing all I can to boost our home, and I will be glad to further any suggestions you may give us. Only people in evening dress are permitted to dance in this cafe, so you see we cater to a class who can afford to travel, and I am sure that a lot of them will be traveling to Hawaii soon.

"The other evening I played for the great Movie Ball at Madison Square Garden. We played for the World Film Company and Miss Kane, the leading woman, wore a half million dollars worth of diamonds.

Had Six Policemen.

"We followed her around playing, surrounded by six policemen and about 500 spotlights were thrown on us. We paraded around the large hall and it is the most wonderful sight I ever saw or was ever in. It seemed to me that there were about a hundred thousand people there, and you can bet Hawaii was right in it again. It was a big boost for us, too, for every eye was on us as well as on the half million dollar doll.

"George Kalamahi and his Hawaiians are here and they are playing at the Biltmore hotel. Later on we may go on the road in an act which is being built for us. I also have a chance to play at Chanley's, Rector's and Sherry's.

"In other words, we of Hawaii have arrived; that is, the booking agents are now after us and want us and personally I can say that our prestige has been established, for the public wants us, demands us, and we can deliver the goods. They cannot get along at this place without Hawaiian music.

"People wonder how we speak such beautiful English and then I tell them about our wonderful schools and everything."

## CLEMONS TO BE SENIOR JURIST OF U. S. COURT

Henry McConnell, special examiner for the department of justice, who has been in Honolulu for the last several weeks, today settled a question which has been bothering many Honoluluans.

The solution is this: If Horace W. Vaughn is confirmed to the local federal bench, there will be no "first judge" or "second judge" in the United States court here.

There will, however, be a senior judge. Judge Charles F. Clemons will acquire this "title" for the reason that he has been on the local bench for a longer period of time than the other judges. But the powers of the two judges will be equal: one will not have authority over the other.

Should a dispute arise, however, Examiner McConnell states that section 23 of the judicial code makes provisions in this respect. This section of the code reads as follows:

"In districts having more than one district judge, the judges may agree upon the division of business and assignment of cases for trial in said district; but in case they do not so agree, the senior circuit judge of the circuit in which the district lies, shall make all necessary orders for the division of business and the assignment of cases for trial in said district."

The senior judge of the circuit in which the local federal court lies is the senior judge of the circuit court of the ninth circuit, in California.

Foster.

Asked whether any action had been taken which affected Lorenzen, Forbes replied that nothing had been done yesterday. "Another meeting will probably be held late this afternoon and additional evidence gathered by Capt. Foster introduced," he said.

## WILL SOON GIVE OUT REPORTS ON RESERVOIR NO. 4

Governor Nearly Through With Health Department Data on Sanitary Condition

Governor Pinkham notified the Oahu Loan Fund Commission in a communication read at this morning's meeting, that a report on the findings on the sanitary condition of reservoir No. 4 would be furnished to the board within a few days. He has the complete data on hand, and according to Charles R. Forbes, chairman of the commission, expected to have it ready for this morning's meeting.

This means that the proposal to divert water from Hillebrand Glen to Reservoir No. 4, which has been so long under discussion, will be acted on by the commission within a short time. All that it has been waiting for is a report from the governor and from the health department. The governor has the health department's report in his hands, as they refused to report directly to the commission.

There was much discussion at the meeting regarding the leakage from the 30-inch outlet from No. 4, and finally the commission's engineer was requested to act in conjunction with the water works department in an investigation of the exact spot of the break in the pipe and report to the commission. The consensus of opinion seemed to be that the commission should undertake to repair the pipe if it could be done at a reasonable cost.

The engineer was also requested to prepare an estimate of the cost of connecting Reservoir No. 3 with the 30-inch outlet of No. 4. If this work is done it will enable the water works department to use water from No. 3 which is now going to waste for power purposes and save the water from No. 4 for use in the dry season. No. 4 is several times the size of No. 3 and will hold water that would overflow the banks of the smaller container.

The March statement, read at the meeting, showed that out of the \$57,500 appropriated for the various improvements to be carried out by the commission \$3588 had been expended, leaving a balance of \$53,912 on hand.


