## P. M. FINANCIAL SHOWING IS STRONG

What the Pacific Mail Steamship Company is doing and their financial condition is of keen interest to Honolulu people. According to a report just received it is evident that they are strong financially and are planning to build new vessels as rapidly as possible.

The American International Corporation and W. R. Grace & Co. hold approximately 75 per cent of the 200,000 shares of the Pacific Mail now outstanding. Under the plan outlined these concerns by exercising their subscription rights to the proposed new preferred and common stock of the Pacific Mail will hold approximately 12,750 shares of the 17,000 outstanding shares of preferred stock of \$100 par value and 172,000 shares of the 230,000 outstanding shares of common stock at \$5 par value. When all the new stock has been taken up there will remain in the treasury 3,000 shares of preferred and 170,000 shares of common stock.

The new financial plan announced by the Pacific Mail will raise \$2,100,000. This will give the company quick assets of \$3,000,000 against its floating debt of \$2,400,000. It is proposed to pay off \$400,000 of this debt out of earnings and the balance with the proceeds of the new stock. Estimated net earnings for March were \$190,000, or at the rate of \$1,200,000 a year. It will require \$119,000 to pay the dividend on the 7 per cent cumulative preferred stock and the proposed three-year dividend reserve for the preferred will require \$357,000. The common stock is not entitled to dividends until this reserve fund is established, but indications are that a handsome sum will remain for the common at the end of the first year of operation under the increased capital stock. The fact that the common is offered at \$10 a share, which is twice its par value, indicates the good position of this stock.

The new money to be put into the concern represents new ships and the average price paid for the Pacific Mail's fleet is not excessive. The earning power of the fleet is expected to increase from month to month so that the investment in new ships may prove very profitable.

There are now ten ships in the Pacific Mail fleet, with a total displacement of 47,800 tons. Three of the ships, of 10,000 tons each, will operate in the Pacific trade and the other seven will continue in the Panama trade. The statement of assets just made by the company places a valuation of \$4,769,871 on the combined fleet, equivalent to about \$100 a ton. This is \$40 a ton greater than the pre-war appraisal value placed on the fleet of the International Mercantile Marine. The appraisal at \$100 a ton, however, is below the market value of tonnage. It must be considered, also, that the three Pacific liners of the Pacific Mail are first-class ships and only a few months old.

The Alpina came off the drydock to day and is now at the railroad wharves loading pines for San Francisco.

The Inter-Island steamer Maui arrived this morning from Hawaii with 38 empty gas drums, 19 empty oil barrels and 74 head of cattle.

## MARINE GOSSIP AT OTHER PORTS

London board of trade returns for April show that British imports increased \$10,230,000, while exports increased \$32,240,000. Imports of food and chemicals show increases, but cotton imports show a decrease of \$12,500,000. Exports of manufactured iron and cotton products show increases of \$6,250,000.

Standard Oil Company is said to be owner of 18 boats to be constructed at the new Chester, Pa., shipyards. Since the British government commandeered 52 of the Standard Oil boats, sailing under the British flag, the company has placed contracts for 20 vessels on the Atlantic and the Pacific coasts.

George J. Baldwin, president of the Pacific Mail Steamship Company, believes there is no reason why the United States should fear its ability to withstand foreign competition which will develop in all trades at the close of the war, provided shipbuilders adopt the British policy of greater specialization. He believes there will be a general rise in labor costs in Great Britain which will tend to equalize the costs of production in the two countries.

Eleven sailing vessels of various types were chartered recently at San Francisco for 1917 voyages from North Pacific ports to Australia with lumber. The charter prices ranged from 120 to 125 shillings, which is the prevailing rate for 1917 passages. The charters were the chief matter of discussion on the floor of the exchange this morning, and there was a great deal of disappointment expressed at not seeing some of the vessels command a higher rate.

One prominent San Francisco shipping man said that it is apparent that next year's charter price will not reach the high mark freely predicted several months ago.

The Lewers & Cooke schooner Robert Lewers arrived in Honolulu last night, 28 days out from Port Gamble. She brought 986,000 feet of lumber.

The following British steamers are due at this port via the Canal for bunkers: Skipton Castle, Kioto and Bolton Castle. The Japanese steamer Wakasa Maru is also due.

The Japanese steamer Towa Maru arrived this morning from Port Arthur, Tex., via the Canal, and docked at Pier 10 for bunkers. Capt. S. M. Kamai is master. She is on the way to Manila with 59,926 cases of kerosene and 20,000 cases of gasoline. She is under charter for the Texas Company of Houston.

## JAPAN BUILDING NEW VESSELS RAPIDLY

The ship-building industry of Japan is now turning out as rapidly as possible merchant ships to meet the heavy traffic demands and take advantage of the high freight rates.

The number and tonnage of tramp steamers, says the Japan Daily Mail, has been strikingly extended since the outbreak of the war. A statement from the director of the shipping at Tairei bureau in the ministry of communications credits Japan with 272 tramp steamers, displacing more than 1,000,000 tons, the combined tonnage amounting to 7,100,000 tons. Of the number 112, with a total of 249,255 tons, are run by the owners themselves, while 160, with a total of 467,554 tons, are chartered.

Of the whole number, 188 ships, with a total tonnage of 423,021, are run in the coastwise trade, while 84 bigger ships carry on the ocean trade, these being distributed as follows: European routes, 14, tonnage 57,517; North American routes, 34, tonnage 129,825; Australian routes, 4, tonnage 11,790; Indian routes, 17, tonnage 56,560; South Seas, 12, tonnage 36,281.

## MAKURA IN WITH BIG LIST OF PASSENGERS

The Canadian-Australasian steamer Makura arrived in Honolulu this morning and docked at Pier 7 at 10:30. She will sail again between one and two this afternoon for Vancouver. She will take mail for the coast except registered mail and packages.

Capt. Phillips reported that the entire trip was very pleasant, fair weather prevailing throughout the voyage.

The Makura had a large list of passengers on board, as travel to the mainland is steadily increasing. She had on board 170 through passengers and 40 for Honolulu. She brought about forty tons of freight, consisting of 250 bags of onions, 348 cases of tea and 40 cases of jam. Ten tons of this was for this port.

A sad sight on the Makura was the number of wives, mothers and sisters in mourning who are going to England. The war is on the other side of the world, but incidents like this bring it home to Honolulu.

There are 30 passengers booked for the passage to Vancouver.
