

BREAK WITH MEXICO BY THURSDAY; TROOPS IN TRENCHES

Murder, Then Suicide HE SLASHES WIFE, THEN SELF, WITH NEW POCKET-KNIFE

**Manuel Gomes Kills Woman,
Menaces Her Sister, Then
Ends His Own Life.**

**JEALOUSY AND BOOZE
MINGLE IN GRIM TRAGEDY**

**Man Had Visited U. S. Mar-
shal Yesterday to Have
Spouse Arrested**

Manuel Gomes, Portuguese, killed his wife, Josephine, Hawaiian, and then himself about 8:30 this morning at the residence on Kalia lane of Mrs. Margaret S. Andrade, the wife's sister. He used a newly purchased pocketknife and death came almost instantly.

Mrs. Andrade was an eyewitness to most of the tragedy and would herself have been killed had she not run frantically from the house with her four children and called the police.

The victims were hurried in the emergency hospital ambulance to the Queen's Hospital, but both died before arrival there.

Gomes was an engineer for the Pioneer Mill Company of Lahaina, Maui, and married Josephine about seven years ago at Waialeale, Maui. A baby boy and a year-old girl living with relatives in Maui survive.

Drunk and Jealous Causes.

It was the old story of jealousy. The wife and husband quarreled at the Andrade home this morning and in a drunken rage the man threw the woman on the floor, nearly severed her head from her body and followed quickly with the fatal thrust in his own throat.

Mrs. Andrade says she tried to stop him after he had killed her sister, but he shouted, "You'll get it, too," and lunged for her as she fled.

After seeing two lives snapped off suddenly, Mrs. Andrade told her story calmly this morning and remarkably straight. She knew nothing about funeral arrangements and said pitifully to a reporter, as she sat in tears, "Please will you tell them through your paper that I haven't any money to make funerals? I'm very poor. Will the county people help me?"

Desperate Month Ago.

The sister came to Honolulu from the Lahaina home in Maui about a month ago, following some trouble with her husband, and made her home with Mr. Andrade and Mrs. Andrade, says the latter. Saturday Gomes arrived in the Kingdom and "made up" with his wife. Yesterday he borrowed passage money from Mrs. Andrade, she says, and left on the Claudine. His wife kissed him goodby at the wharf and apparently the best of feelings existed.

This morning Mrs. Andrade saw her sister running down the street, and to her amazement, the husband was following her. Gomes explained that he jumped overboard after the Claudine had put out to sea and swam back to shore. How far he swam he didn't say, but the last the wife saw of him he was on the Claudine's deck.

Steps to Buy Knife.

Gomes had stopped at a store to buy something, which later proved to be the pocketknife that was found sticking in his throat when the police came. The wife and he started a heated argument on the front porch.

DR. SUN YAT SEN WILL WORK IN ANY PLAN TO BETTER GOVERNMENT

REPUBLICANS TO DRAFT PLATFORM IN JULY SESSION

Hawaii's fall campaign was preliminarily launched yesterday afternoon when the Republican territorial central committee held a meeting, fixed the date of the Republican platform convention and appointed a committee to take charge of convention arrangements.

The platform convention will meet on Monday, July 17, in Honolulu, and the committee on arrangements consists of William Thompson, chairman; A. W. Eames and A. D. Cooper. The meeting place and all preliminaries are to be settled and the committee was given full power to act.

Since the direct primary has done away with the party nomination conventions, this platform convention is the most important Republican gathering of the biennial period. A territorial platform is to be drafted and from this convention are selected the central committee, the executive committee and the party chairman, who is chairman of the central committee.

DETAILS OF ROW IN PRISON CAMP SHOW DEEP PLOT

**Ferguson, Lyons and Monroe
Ringleaders in Plan to
"Get" Billy Woods**

**WHITE CONVICTS LEAD
GANG, REPORTS SAY**

**Waimea People Stirred Up By
Outbreak; Say Too Many
Chances Given**

HILO, June 26.—Held at the point of a revolver in the hands of Warden Billy Woods and threatened with being drilled with lead if he attempted to use a rifle that was in his possession, F. J. Lyons, a man who is serving a long sentence for second degree murder, was forced to surrender and give up without a struggle on Saturday evening last at the Waimea prison camp.

Lyons is the man who was found guilty of second degree murder in the case of the Iwilei butchering of a Japanese hack driver a year or so ago.

Before he was taken by Woods on Saturday evening Lyons shot twice and badly wounded a Porto Rican prisoner who was employed as a baker at the prison camp. The Porto Rican was shot through the left arm and also through the left side just beneath the heart. An inch higher and it would have been murder.

H. F. Ferguson, the man who shot dead Police Officer Abren on the windward side of Oahu three years ago, was in the affair also. He and another white man, Monroe, who is in jail for burglary, are now accused of being in a conspiracy to murder Billy Woods. Still another prisoner, Rayley, who killed his wife in the telephone office at Honolulu two or three years ago, is suspected of being in the conspiracy to do up Woods.

It all happened on Saturday evening last at Waimea. Woods was at Deputy Sheriff Lindsay's house for dinner and the camp was in charge of Deputy Warden Parker. As usual Woods rang up the camp to find out how things were. A prisoner named Dalley answered the phone, and he declared that all was well at the camp. His voice sounded most peculiar to Woods at the other end of the line and he repeated the question as

HOSPITAL SEEKS TO SAVE ITSELF FROM NEW LOSSES

**Queen's Hospital Superintendent
Tells How Institution
Suffers Under Act**

The Compensation Act is "all wrong," according to Queen's hospital authorities, and they have started operations this week to correct what they term the evil as far as they are concerned. Startling developments are promised.

Werner Roehl, superintendent of Queen's hospital, has inserted an advertisement in a local publication to the effect that here after all employees, whether indemnified or not by compensation insurance, will be held liable for all hospital charges incurred in the treatment of employees received at their instance.

Roehl wasn't a bit backward about explaining the reason for the "ad" to a Star-Bulletin representative today. "The Queen's hospital has been the goat so long in this compensation matter that something definite and final will be done," he said. "We have been taking compensation patients here for months and invariably receiving only a small part of the cost of their treatment. From now on we will not take cases if payment in full for their care is not guaranteed beforehand."

To Treat Desperate Cases.

Roehl says the Queen's hospital will certainly not refuse desperate or serious cases, but the ordinary accident and fracture kind will be turned back to the emergency hospital if not accompanied by the required guarantee from the employer.

"Most ordinary fracture cases bring about \$50 in compensation insurance," says Roehl, "and it is the sense of the law that these cases be treated and cured inside of two weeks. In most cases this is impossible and while we are paying our grocer and meat and light and nure bills and all the rest the attending doctor usually draws out his full fee and leaves us a few dollars for several weeks' trouble and expense. 'PICTURE-BRIDE' STOLEN, REPORT AT U. S. STATION

**Immigration Officials Hear
Story and Inspector Halsey
is Investigating**

**PRETTY OKINAWAN SAID
TO BE TAKEN BY RUSE**

**Bona-fide Suitor From Kaula
Arrives to Find His Girl
Gone With Another**

How a Japanese picture-bride was stolen from the United States immigration station last Saturday by a countryman who posed falsely as her intended husband is a story which is stirring the Japanese community.

Inspector R. L. Halsey, in charge of the immigration station, when questioned by the Star-Bulletin this morning, said:

"I have heard the reports of this around here but I don't know the facts," he said. He is investigating the reports.

The story which is told among the Japanese with circumstantial detail is that the girl, a 19-year-old Japanese of the Okinawan race, arrived on the Shinyo Maru from Japan on June 19 and as usual went to the immigration station, where the "picture-brides" are detained until claimed by their husbands-to-be. The girl's name is given as Ushi Ishikawa. Her intended husband is said to be one Shoden Ishikawa of Kokaha Plantation, Kaula.

According to the story told by Japanese, and which has also been heard at the Japanese consulate, Ishikawa was unable to come from Kaula at once to claim his bride on account of there being no immediate steamer facilities, though he had received wireless word that the bride was waiting.

It appears that the news that a beautiful picture-bride was at the station waiting for a husband, was circulated in the Japanese community, and one G. Toyama, a plantation laborer at Heala, learned of it and concocted the plan to steal the girl, if she should prove, on personal inspection, to be as good-looking as reports represented. Accordingly, it is said, he went to the immigration station, saw the girl, was satisfied, and hurried to a Japanese hotel on Beretania street, where he registered as Shoden Ishikawa or Ishihara of Kaula, Kaula. He is understood to have told the hotel manager he was here from Kaula to receive his picture-bride who came on the Shinyo, and on this representation, it is said, the hotel manager went with him to the immigration officials to be his witness in claiming the girl.

Toyama is said to have been examined by the immigration authorities and to have passed this examination, upon which he was allowed to take the girl from the station. He is said to have taken her to the same hotel where he had registered and to have remained until Monday morning. Expecting that the bona fide husband would arrive from Kaula yesterday, it is said Toyama left the hotel early and went back to Heala with the bride.

The Kaula man, arriving early in the morning, went to another hotel and asked the manager there to accompany him to the station and help get the bride he had brought from Japan. When the "unlucky" man reached the station and was told that some one else had taken his bride, he was torn with rage and despair, summoned his friends, and after inquiry found that Toyama had gone to Heala. It is said they went to Heala and brought back the girl, but what happened to Toyama now it seems to have been heard there is going to be some trouble.

Counsel Mori was absent from the consulate this morning when telephone inquiry was made. One of the consular staff said that the news of the abduction had reached the consulate but they were not in possession of the facts. Whether the consul would investigate he could not say, nor could he confirm the report that the disappointed Ishikawa had asked the consulate to take the matter up.

FRENCH RECAPTURE VERDUN POSITION

Another Bloody Fray for Possession of the Thiaumont Trenches; News of Arenas

PARIS, France, June 27.—In another of the bloody struggles which are making the torn trenches at Thiaumont famous, the French today recaptured a section of the positions taken by the Germans a few days ago.

The terrific struggle for possession of the village of Fleury is still in progress.

Today's official announcement adds that three Allied aeroplanes have shelled German warships on the Belgian coast.

BERLIN, Germany, June 27.—There is much activity today on the British line in the west as well as on the north wing of the French line. Along the Franco-Belgian front the British are talking the aggressive.

MARSEILLES, France, June 27.—The French steamer Fournel and the British steamer Cardiff have been submerged and sunk in the Mediterranean sea.

ROME, Italy, June 27.—Following up their recent successes against the Austrians, the Italians on the Trentino front have pushed the enemy farther back, capturing Posina and Arsiere.

EL PASO, Tex., June 27.—Two negro troopers captured by the Mexicans at Guzman were brought into Juarez today and lodged in the Mexican jail there. They were ragged and half-dead from hardship. The discussion was to begin immediately after the executives had been welcomed to the state and city by Governor William R. Spry of Utah, who is to be host to the visiting governors.

Governor Hiram Johnson of California was expected to speak on "A Land Settlement Policy," which is one of the important questions in all western states. Other addresses on various phases of the same subject were to be given by Governor Ernest Lister of Washington; Governor James Withycombe of Oregon; and Governor Emmet D. Boyle of Nevada.

Governor Charles A. Carlson of Colorado who was to have taken a leading part in the meeting was unable to attend because of recent illness. Several eastern governors also are to make addresses. The conference is to last three days.

AMERICANS AND MEXICANS AT NACO READY NOW FOR BATTLE; DELAY HELPS U. S. CAMPAIGN

**Trains Loaded With Guardsmen Sweep Southward From
Many States--Bisbee, Arizona, Menaced By Raiders
and 22nd Infantry Rushed For Reinforcements--Car-
ranza Unyielding on Release of Captives**

WASHINGTON, D. C., June 27.—A break with Mexico by Thursday at the latest, and possibly tomorrow, is now the prospect.

Though the delay is irksome in some quarters, every hour hostilities are postponed is helping the U. S. plan of campaign. It is enabling the American commanders to get the state troops to the border and so dispose the national guardsmen as to allow the regulars the fullest mobility.

Officials in high circles express the belief today that the president will wait until Thursday at the latest for the release of the 10th Cavalry men who are held in jail by the Mexicans, supposed at Chihuahua. Possibly the president will demand decisive action tomorrow.

There will be no move of actual aggression until a substantial force is available at the command of General Funston. This delay in the breach of relations is favorable because it betters the position of the troops to take swift and effective action. It also allows more time for the American civilians to get out of Mexico and for other foreigners to flee who are afraid that in case of war between the two nations their lives or property will be imperilled.

Advices to the war department from Gen. Funston today indicate that trains loaded with state troops are sweeping southward from all points toward the Mexican border.

Under the war department orders, the various state commands are reporting direct to Funston when they are ready to move. He then sends instructions as to the point where they are to detain, and then informs the war department as to their disposition.

U. S. Embargo Already Felt in Mexican Towns Across The Line

SAN ANTONIO, Texas, June 27.—The embargo placed on the exportation of virtually every commercial article across the Mexican border from the United States has already affected the Mexican towns near the line. At Nuevo Laredo, across the river from Laredo, Texas, the Mexican troops have moved because of lack of forage for their horses.

Troops Entrench at Naco: Rumor of Raid on Bisbee, Ariz., Heard

SAN ANTONIO, Texas, June 27.—Today the American troops are completing entrenchments thrown up at Naco, according to advices received by General Funston, and are facing 1500 Mexican troops just across the river. Here there is a possibility of battle the moment hostilities are declared.

Information has reached General Funston's headquarters that the Mexicans have planned to sweep across the line into Bisbee, Arizona, and raid the copper smelting concerns around Bisbee, as well as the stores and other establishments.

Because of this disquieting report, Gen. Funston today ordered the 22nd Infantry rushed from Douglas to reinforce the rather slim number of troops guarding the line near Bisbee.
