'PRINCESS' THERESA LAYS CLAIM TO CROWN LANDS OF ALL KAMEHAMEHAS

Declares She and Mrs. E. K. Pratt Will Bring Suit Shortly For Their Recovery

The fact that a suit already is pending to eject her from the so-called Gore lot, and that the territory, expected to see for registry of title to the property, is not bothering Mrs. Theresa Wilcox Belliveau. Matters carrying more weight and of more importance, she declares, are occupying her thoughts. In an interview with a representative of the Star-Bulletin today, Mrs. Belliveau, better known as "Princess" Theresa, laid claim to all of the crown lands of the Kamehamehas which descended from Kamehameha V, the last of the line. She also lays claim to any and all lands which descended from Kamehameha V and which are now held by the Bishop Estate. Promises Early Suit. The "princess" claims that herself and Mrs. Elizabeth K. Pratt are the only descendants of the Kamehamehas and the real owners of the crown and other lands. Very shortly, she declares, she and Mrs. Pratt will bring

suit against the territorial government and the Bishop Estate for the attempted recovery of the lands in question. As her attorneys to represent her in her contemplated litigation, the "princess" says that she has retained the law firm of Thompson, Milverton and Cathcart, former Governor Walter F. Frear and Judge John T. De Bolt. Kapoloani Park is but one portion of the crown lands which the "princess" alleges rightfully belongs to herself and Mrs. Pratt. She also claims certain tracts of land in Makiki heights and lands now held by the Bishop Estate. Make Claim as Grandchildren. "As grandchildren of the Kamehamehas, we claim all the estate of Kamehameha I," the "princess" declares. Just when her contemplated suit will be instituted, the "princess" is not certain. She prefers, she says, to wait until the litigation over the Irwin site is finished, and until the ejectment suit brought against her by the Bishop Estate last November, to eject her from the Gore lot, which she now occupies, is finished. If the territory intends to bring action in-

volved the Gore lot, she adds, she may wait until that litigation is completed. Offers Family Tree. "Princess" Theresa contends that Kamehameha I was a half-brother of her grandfather. She outlines the following table of genealogy to uphold her contention that she and Mrs. Pratt are the sole heirs: Kalani Kupuapakaianini Keoua was the father of Kamehameha I and of the latter's half-brother, Theresa's purported grandfather; Kalokumale, half-brother of Kamehameha I, married Keotokealani, the issue being a girl, Kaohelaiani, who married the high chief Nuihi; G. Laanui (k), the issue of Kaohelaiani and Nuihi, married Owannui, the issue being Elizabeth K. Pratt and Gideon K. Laanui; Gideon Laanui married Kamaikaopa, the issue being the "Princess" Theresa. The "princess" contends that she and Mrs. Pratt are the real owners of the crown lands, of which, she says, there is a record in Congress. When Liliuokalani was queen, she says, the queen sent Paul Neumann to Washington to negotiate a sale with the United States for the crown lands. F. S. Pratt, who was then Hawaiian consul at San Francisco, protested, telling Neumann that the queen had no right to sell the lands, as his wife, Elizabeth K. Pratt, and her brother, were the only heirs to the lands, the "princess" continues. Neumann, the princess adds, came

back to Hawaii, and shortly after Pratt was recalled. "And the crown lands were never sold and have never been sold," declares Theresa. With her contemplated suit in view, the "princess" says she is not worrying about any suits which may be brought involving the Gore lot, her present home. DR. SINCLAIR RESIGNS FROM HEALTH BOARD. At the August meeting of the territorial board of health late Thursday the resignation of Dr. Archibald N. Sinclair as pathologist and director of the anti-tuberculosis bureau was accepted, to take effect the last of this month. The board appointed Dr. L. L. Patterson, school medical examiner and acting superintendent of the Oahu Insane Asylum, as Dr. Sinclair's successor, the appointee to take the position September 1. Dr. Sinclair will devote his time to private practice and his other duties as acting surgeon of the U. S. public health service and

superintendent of the Leahi Home here. Routine business was transacted by the board. Dr. J. S. B. Pratt, the president, presided and other commissioners present were C. J. Campbell, John Markham and George P. Denison. The board decided to buy a modern computing machine for its increasing statistical work. An automobile for use of the superintendent and physician at Molokai Leper Settlement was ordered purchased. GEO. E. H. BAKER WEDS MISS ELIZABETH WEING. George E. H.
