British Submarine Commander Tells of Torpedoed Vessels; Doesn't Know Damage

BUCHAREST CLAIMS SUCCESS IN DOBRUDJA

District Where Von Mackensen is Operating Scene of Hot Fighting

(Associated Press by Federal Wireless)
LONDON, Eng., Nov. 7.—That two German dreadnoughts were struck by British torpedoes instead of one, as first reported, is the report now made by a British submarine commander to the admiralty. He says that both of the great warships were of the Kaiser class. He does not know the fate of the vessels. The torpedoing is said to have taken place in the North Sea.

The Kaiser is of 24,310 tons displacement, and was completed in 1912.

AUSTRIAN AND ITALIAN WAR-VESSELS SUNK IN DEADLY DUEL ON THE SEA

ROME, Italy, Nov. 7.—An Austrian submarine and an Italian destroyer have been sunk in a duel, presumably in the Adriatic Sea. The submarine attempted to torpedo an Italian transport, which escaped. The majority of the crew of the destroyer were rescued. From the submarine 13 were taken prisoners.

RUMANIAN PRESS BACK GERMAN IN DOBRUDJA

BUCHAREST, Rumania, Nov. 7.—The Rumanians on the Dobrudja district are continuing their successes against Gen. von Mackensen's German-Bulgarian forces. They have made progress on the entire Dobrudja front.

BERLIN REPORT TELLS OF RUSSIAN SITUATION

BERLIN, Germany, Nov. 7.—The Russians have forced back the Teutons in the region of Tulgheis. West of Bodza pass, on the Transylvanian front, the Teutons have gained. The capture of a bridge-head on the Stockhod river, Russian southeastern front, is reported. Russian artillery today was active between Drvinsk and Lake Narocz. The British made an attack near Eaucourt L'Abbaye, but it was repulsed.

GERMAN OFFICIAL CABLEGRAMS

BERLIN, Germany, Nov. 5.—The German admiralty reports that a submarine on October 23, west of Ireland, destroyed a small English cruiser of the Elber type, with two funnels.

GERMAN ARMY HEADQUARTERS, Nov. 6.—On the Somme today there was a continuous battle from yesterday. The French and English with their strongest forces and using their whole firing strength made a powerful advance against the front of Gen. von Heudow's army. The troops of different parts of Germany, under Gens. Baron Marschall, von Deimling and von Gartner withstood the assaults unshaken and inflicted a severe defeat on the enemy. Parts of the Strassburg corps, Saxony, Baden, and from Berlin and Hansaito and Meiningen infantry regiments gained special distinction. The Allies on the whole front from Lesars to Bouchavesnes, about 20 kilometers, suffered heavy losses and accomplished nothing except a small local gain north of a part of St. Pierre Vaast wood. Wherever the enemy in other places advanced into our line they were immediately ejected and left 10 officers and 310 men and much booty in our hands.

Northeast of Lesars more than 70 prisoners and 11 machine guns were brought in. Near Soissons the attack of the feeble French detachment was repulsed.

On the Crown Prince's front, right of Meuse, in the Hardamont sector, there was violent artillery and hand-grenade fighting today.

Eastern war theater, Prince Leopold's front: No important events. Archduke Carl's front: Engagements in Toelgys sector and between Altschanz and Bodza pass road went on today without change in the situation. Southwest of Pralou we conquered the height of Laedem and made further progress southeast of Rotenthurm pass. On both sides of Szdurk pass Rumanian attacks were repulsed. We took prisoner on south front more than 450 men.

In Balkans, nothing new.

VILLA BANDITS MURDER POWERLESS AMERICANS

TUCSON, Ariz., Nov. 7.—Arthur Williams, agent for an automobile house at Chihuahua, arrived here yesterday in a battered automobile after he had been chased by Villa bandit sharpshooters in another car. A woman and Williams' little daughter were killed. Williams' wife was killed at Chihuahua before the chase.

ANOTHER OUTRAGE LAID TO VILLISTAS

EL PASO, Tex., Nov. 7.—Sixty-seven bars of silver, valued at \$50,000, belonging to the American Mining Company of Parral, are reported to have been taken from Edgar Koch by Villa bandits on October 27. Koch is said to be the German consular agent at Parral.

AUTO THIEF MAY HAVE MET ACCIDENT

GREEKS FLEEING FROM AUSTRALIA ABOARD SONOMA

Not a pound of wool and only 22 through first-cabin passengers were on board the Oceanic liner Sonoma, Capt. J. H. Trask, when she docked at Pier 10 about 9 o'clock this morning, delayed an hour and a half by the strong trades which have been blowing since Sunday. She will not steam for San Francisco until 8 o'clock to night, taking the next mail.

Officers of the steamer said the wool embargo is still on in Australia and also that people of military age are not allowed to leave the country. There is a heavy list of second-cabin passengers, however, 74, of whom 16 or 17 are Greeks whose shops in Sydney were wrecked recently by mobs angry at Greece's neutrality. "They are getting out while the going is good," remarked Purser H. J. Holtz.

One Greek, a man named Carydis, died of Bright's disease three days ago and was buried at sea. The Sonoma's through cargo from Sydney is light, 560 tons. At Pago-Pago, however, 362 weight tons of copra, 7420 bags, were loaded and here the liner is taking on 800 tons more, of canned and fresh pigons, sugar, bananas, junk and general cargo. Passengers out tonight from Honolulu will be 30 cabin and 10 steerage.

NEW YORKER SAYS "LOOKS WILSON"

A Honolulu attorney this morning received a night letter from a New York businessman, who is also a Democratic politician, a Marconigram declaring that the best information in his possession is that the election will go for Wilson. His message says: "New York Herald poll shows 307 delegates Wilson, 224 Hughes, on returns equaling 1 per cent of the popular vote. The New York Times and the New York Evening Post consider Ohio Democratic and Indiana, Illinois, New York and Connecticut doubtful. The odds are 10 to 8 on Hughes and there is plenty of Wilson money. Best information is Wilson will win."

Election Day Extra

MILITIA HEADS SEND RULES ON DRILL STRENGTH

Numbers Based on 60 Per Cent of Average Enrolment of Men and Officers

WAR SECRETARY WILL PRESCRIBE INSTRUCTION

Commanding Officers to Keep Monthly Record of Armory Attendance

Information relative to the necessary strength of militia companies, detachments, etc., which is requisite at drills in order that militiamen will be in line for pay from the government was received today by Hawaii National Guard officers who have been anxiously awaiting its coming for a month.

Generally speaking, it requires that for a six-month period there shall be an average attendance of 60 per cent for enlisted men and 50 per cent for officers, of the average enrollment for the six-month period.

The orders which were received from the acting chief of the militia bureau at Washington, D. C., are in part as follows:

Attendance at Drills

For officers and men of a company, a troop, battery or detachment, the attendance at armory drills for each semi-annual period must exceed 50 per cent of the authorized minimum commissioned peace strength of the company, etc., for officers, and be not less than 60 per cent of the authorized minimum-enlisted peace strength of the company, etc., for enlisted men, provided, that credit for attendance at drills shall not be given unless the period of actual military instruction participated in by each officer and enlisted man at each assembly, exclusive of rests and interruptions, is at least one and one-half hours in duration, and provided that the character of the instruction is such as may be prescribed by the secretary of war. Where the enrolled enlisted strength of a company, etc., exceeds the minimum strength prescribed by the war department, the percentages for the average enrolled strength of the company, etc., for the semi-annual period. Credit for drill attendance of company officers and enlisted men will not be allowed on account of time occupied with correspondence schools or for attendance at schools for officers and non-commissioned officers.

Must Keep Records

The commanding officer of each company, etc., shall keep a monthly record of armory attendance, in triplicate, of each officer and enlisted man of his organization at every drill or assembly for instruction, showing the name of the person, the date of the drill, the period during which he was actually present and under instruction in uniform, and the character of the drill and instruction for the entire period. This roster of attendance certified to by the senior officer on duty with the organization will be again certified by the battalion commander or officer of corresponding command, providing he is on duty at the station of the company, and delivered or mailed to the regimental commander immediately after the last drill or instruction of each month. Regimental or separate battalion, etc., commanders will forward the original reports of attendance directly to the chief of the militia bureau, and the duplicate copies to the adjutant general of the state. The triplicate copies will be retained in the organization records.

DR. WU ELECTED FOREIGN MINISTER

PEKING, China, Nov. 7.—Wu Ting Fang, the noted Chinese statesman, was today elected minister of foreign affairs of the republic by a virtually unanimous vote of parliament.

GERMAN SUBMARINE IN FOR RUNS ASHORE AND IS BLOWN UP BY CREW

(German Official)
BERLIN, Germany, Nov. 7.—On the evening of November 4, according to report of the German admiralty, the submarine U-20 in consequence of fog ran aground at Bobberg, on the west Jutland coast. All attempts to float her being futile she called for assistance and the torpedo-boats tried to drag her off but were unsuccessful. Therefore the submarine on November 5 at noon was blown up, after the crew had been rescued by a torpedo boat.

Kauai and Maui Send Reports of Big Vote For All Republicans

WAILUKU, Maui, Nov. 7.—Returns from small precincts already counted, Olowalu and Honolulu, show that the voting favors the Republican candidate by an average of 40 to 20. George P. Cooke, candidate for the senate on the Republican ticket, is leading Dr. Raymond by a big margin in both precincts, with Harry Baldwin, Republican, also well in the lead. Delegate Kuhio is polling most of the vote for delegate. McCandless getting two out of 33 in Olowalu and seven out of 59 in Honolulu.

LIHUE, Kauai, Nov. 7.—Forecast at 2 o'clock is that Kuhio will get 750 votes on Kauai, McCandless 450. Coney and Chandler, opponents for the senate, very close, and the Republican house ticket safe.

Maui "Sample Ballot" Row Grows; Voter Stopped in Booth at Wailuku

WAILUKU, Maui, Nov. 7.—There was excitement in a polling booth at Wailuku this morning when a young Hawaiian, K. Ohialau, was stopped from leaving the booth with a senatorial sample ballot and official ballots folded together in his pocket, after he had deposited his representative ticket.

He was stopped by Inspector Manuel Ross. The voter is a bit "loony."

Dr. J. H. Raymond, Democratic candidate for senate, whose charges of illegal use of a "sample ballot" caused Secretary Thayer to wireless warning from Honolulu to the election officials, has made complaint to the county attorney, who has refused to act. The county attorney says the attempt made by Ohialau was not illegal.

Raymond claims that four federal detectives are here watching for fraudulent voting. He made a summary statement at Wailuku last night to a crowd of 500, where fair warning was read.

Harry A. Baldwin, candidate for senator on the Republican ticket, is scornful of the story that fraudulent voting has been attempted. He declares it absolutely false and a desperate resort of Raymond, the latter seeing himself beaten.

The tension at the Wailuku polls is marked.

LIGHT VOTE QUIETLY CAST MARKS ELECTION IN OAHU'S TWO DISTRICTS

States and Combinations Are Reported But No Open Evidence of Deals is to Be Found at Most Polling Places — Bond Issue is Not Openly Fought By Democrats Though Largest Part of Vote on Questions Will Come From Republicans

Quiet election and a rather light vote were the reports generally received from the various precincts of the fourth and fifth districts after they had been visited by representatives of the Star-Bulletin this morning. There was little open slate making seen, but in some districts there are reports of votes, irrespective of party affiliations, being thrown for some particular candidate or candidates. Such reports were difficult if not impossible of confirmation.

Light Vote Cast
Despite reports that states were to be framed none were in evidence in the fourth district today so far as could be ascertained by close observation. Harmony and quiet marked the voting in the fourth throughout the day. Up to noon the voting was light, 8:30 to 9:30 o'clock being the rush hour. No disturbances of any nature were reported. At many of the precincts, especially the sixth, large crowds gathered, but the crowds were orderly.

So far as could be learned the Democrats made no open fight at the polling places against the bond issue. Reports from the various precincts of the fourth are that a steady vote is being cast for the bond issue, although some of the voters, largely Democrats, openly declared they would have nothing to do with this phase of the voting. Governor Pinkham votes at the fifth of the fourth. He was in the booth only a short time. "Jack" Lucas cast the first vote in this precinct. The fifth was his headquarters a large part of the day. Those men in charge of the booth in the fifth saw first early this morning several women called

at the voting place, asserting that they intended to vote. They appeared chagrined when told that they could not vote.

Up to noon today more than 1500 votes had been cast.

FOURTH DISTRICT
First Precinct—10:35 a. m., 180 votes cast. Voting in the first was fairly heavy throughout the morning. It was reported that the vote on the bond issue was steady, no one declining to vote on the proposals.

Second Precinct—10:20 a. m., 123 votes cast. Several voters asserted openly that they would not vote for the bond issue. The voting was light throughout the morning, the heaviest voting being between 8:30 and 9:30 o'clock. Delegate Kuhio and Former Mayor J. J. Fern voted here. The delegate said he is satisfied he will be elected.

Third Precinct—10:50 a. m., 152 votes cast. Voting here was fairly heavy, with a steady vote on the bond issue. A big rush of late voters was expected after the noon hour.

Fourth Precinct—10:55 a. m., 199 votes cast. A fairly heavy vote was polled here during the morning. Those in charge of the polling place reported none of those registered had expressed refusal to vote on the bond issue.

Fifth Precinct—11 a. m., 127 votes cast. "Jack" Lucas was the first one to vote. It was reported here that a number of those who voted early in the morning asserted they would have nothing to do with the bond issue. Voting was fairly light during the morning.

Sixth Precinct—11:30 a. m., 200 votes cast. (Continued on page two)

CLOSE FIGHT IS INDICATED ON EARLY RETURNS; KANSAS VOTE DIVIDED; COUNT IS INCOMPLETE

NEW YORK, MIDDLE ATLANTIC STATES, WESTERN AND SOUTHERN PORTIONS OF NATION ALL REPORT UNUSUALLY LARGE VOTING—FAIR WEATHER GENERALLY PREVAILS

NEW YORK, N. Y., Nov. 7.—Returns from seventeen districts of 3680 outside the city give Hughes 3980, Wilson 3108. Incomplete. No returns from city yet.

SCHEENECTADY, N. Y., Nov. 7.—One district here gives Hughes 188, Wilson 137. Incomplete.

CHICAGO, Ill., Nov. 7.—Senator Walsh today made public a telegram from Denver on returns counted hourly, declaring that indications are that Wilson has carried Colorado by 30,000.

FORT SCOTT, Kansas, Nov. 7.—Incomplete returns from all nine precincts here give Wilson 1043 votes and Hughes 602.

KANSAS CITY, Kan., Nov. 7.—Ten out of 108 precincts in Wyandotte county give Hughes 428 votes and Wilson 407.

LEAVENWORTH, Kansas, Nov. 7.—Incomplete returns from seven out of 13 precincts give Wilson 501 and Hughes 399.

SAN FRANCISCO, Cal., Nov. 7.—First returns on the presidential election today, as flashed from various cities of the country, show a big vote cast, with the incomplete count indicating nothing either way.

NEW YORK, N. Y., Nov. 7.—An unusually large vote was cast today in this state and in the Middle Atlantic, western and southern states.

Charles E. Hughes at a few minutes after 7 this morning entered his polling-booth in an Eighth avenue laundry and was given a ballot. He voted number 13 in the list of those balloting. When his attention was called to the fact that he had cast Ballot 13 he said, "And I was born on Friday, too."

Topeka Gives Hughes Early Lead

TOPEKA, Kansas, Nov. 7.—Incomplete returns from 25 out of 32 precincts in the city of Topeka gives Hughes a lead, with 1389 to 974 for Wilson. This city is normally Republican.

LATER—Partial count of 27 precincts gives Hughes 3055 and Wilson 1943.

Wichita Starts off For Wilson

WICHITA, Kansas, Nov. 7.—The Kansas system of counting under the double election board plan is in operation here, with returns incomplete for the city. In the vote so far tabulated, 16 out of 26 precincts in Wichita give Wilson 880 and Hughes 416.

LATER—Incomplete returns from 26 precincts give Wilson 1080 and Hughes 808.

President Cheered at Princeton

PRINCETON, N. J., Nov. 7.—President Woodrow Wilson voted here early this morning. He was attended by a large group of friends and scores of photographers and movie camera men crowded around him to take his picture in various attitudes. He was cheered by the students vociferously.

Mrs. Wilson accompanied the president. After voting he returned to Shadow Lawn in his automobile.

Weather is Generally Fair Today

NEW YORK, N. Y., Nov. 7.—The weather is generally fair today throughout the country, except in the upper Mississippi valley, where it is cloudy and threatening, with light showers, and in Western Colorado and Wyoming. Here there is some snow and an early vote has been the result.

Massachusetts Begins For Hughes

NEW ASHFORD, Mass., Nov. 7.—The first returns from 23 voters show that Hughes got 16 votes and Wilson 7. The voting in New England today is heavy.

LATER—Latest count, with one-third of the city tabulated, gives Hughes 1929 and Wilson 1737.

NO STOCK MARKET

Today being a national election and a legal holiday in all parts of the United States there have been held no business sessions of any stock or other exchanges in any cities of the country and the New York stock list is therefore omitted.

Thursday, Nov. 9, has been named as payday at Schofield Barracks. Capt. Thomas R. Harter, with an assistant, will officiate as paymaster.
