

### Awarded Damages.

The case of Maria Correa vs. L. M. Baldwin et al, trespass, which was continued from the June term was heard before Judge Kepoikai this week.

This is an old case on the calendar, since 1903, in which judgment was obtained against the husband, and sheriff's department seized some cattle and sold them to settle the judgment. The case had been up to the Supreme Court once on its merits, and an appeal was made on the outcome of the case before Judge Kepoikai. It was brought out that only a portion of the cattle attached and sold were the property of the husband the balance being owned by Maria Correa, the wife, who brought the suit. Judge Kepoikai awarded her damages to the amount of \$90.00. J. M. Vivas was the attorney for the plaintiff and J. L. Coke for defendant.
