BY AUTHORITY.

Promulgation of Ordinance

ORDINANCE NO. 2.

SECTION 1. Whenever any ordinance shall have received the approval and vote of a majority of the members of the Board of Supervisors the original thereof as passed shall be signed by the Chairman of the Board presiding at such meeting, and attested by the Clerk of said Board; such attestation, among other things, to recite the fact and date of passage, and be impressed with the County Seal.

SECTION 2. It shall therefore be the duty of the Clerk of the Board as soon as practicable to cause a true copy of such ordinance to be posted upon a bulletin board in front near the rooms occupied by the Board of Supervisors, and to also cause a true copy thereof to be published once a week for a period of two consecutive weeks in a newspaper of general circulation, published in the County of Maui.

SECTION 3. This ordinance as well as all ordinances that may hereafter be passed by the Board of Supervisors of Maui County, shall take effect and become obligatory only from and after its and their publication as provided in section 2 of this ordinance, unless otherwise specially provided in any given ordinance.

Buffalo Bill's Show Meets With Disaster.


