SPECIAL TO THE MINER. The Legislature. NINTH DAY—COUNCIL. MORNING SESSION.

Tucson, Jan. 9.—11 A. M.—The bill for removing the Capitol from Tucson to Prescott, passed the Council this forenoon by the following vote: Ayes—Messrs. Raggies, Goodwin, Jones and Redondo.

Mat. Blodsoe was shot through the head and killed, this morning, in Tucson, by a San Diego sport, by the name of Kerr. The altercation originated over a game of cards. Another revolution in Sonora.

TUCSON, A. T., Jan. 9. EIGHTH DAY.—The Supreme Court adjourned until Saturday next, when opinions of the Court will be announced. All cases are now argued and submitted.

Ex-Governor J. J. Pesquiera has pronounced against martial law in Sonora, and therefore against Gen. Mariscal, Acting Governor and federal military commander of the State.

Pesquiera has his headquarters at Canyon de Agulita, with 400 men, and is in communication with 600 men, and is in communication with 100 men.

The above Mexican news arrived this morning by special messenger, direct from Guaymas, in seven days.

New York, Jan. 8.—The Herald's New Orleans dispatch says the Republicans are collecting in the militia daily.

Gen. Longstreet will be in command. No for-aid opposition will be made to prevent Nichols being inaugurated, but all the State officers are strongly guarded by police, and will be defended from any attempt to take possession.

Nichols and Packard will be inaugurated on Monday, by their respective followers. Each of the Governors will doubtless proceed to organize a State government.

The Democratic Legislature has issued an address to the people, rehearsing events during and since the canvass.

Washington, Jan. 5.—The appropriation for transportation of United States notes and securities, for the fiscal year, is exhausted, and unless a deficiency appropriation is immediately made, the Treasurer will not be able to transport funds from one point to another, and the result will be a virtual suspension of payments by the Government in several localities.

The House Commerce Committee will next week report a bill providing for a new law governing migration—settling aside State migration law as unconstitutional, and placing all laws connected with migration, under the national government.

The South Carolina Committee of the House cannot report for several days, as the reporters require time to write out their notes. They will report that the State cast its vote for Hayes for President, and for Hampton for Governor.

San Francisco, Jan. 6.—Another petition, that of Samuel Lick, the half brother of James Lick, has been filed for letters of administration on the Lick estate, and the petition of James W. Lick was dismissed, on his own motion. Samuel Lick's petition sets forth some facts, as in former petitions, in opposition to the application of John H. Lick.

New York, Jan. 8.—A report is circulated that a private dispatch has been received from Montreal, stating that young Bennett and May had fought a duel, and that Bennett received a bullet in his bowels.

New Orleans, Jan. 8.—Both, Nichols and Packard were inaugurated to-day as Governor. There was no fighting.

San Francisco, Jan. 8.—The San Francisco Stock Exchange adjourned to-day, on account of the death of its Secretary, Frank Swift, on Saturday last.

In the Pacific Stock Board, to-day, bull ion fell to 89, and Justice, to 111.50; other stocks unchanged. The California mine declared its regular \$2 dividend.

New Orleans, Jan. 7.—It is understood that the military authorities have orders to transfer 3,000,000 pounds of ordnance and ordnance stores from Baton Rouge to New York, including 300 barrels of powder, guns, shot, shell, etc.

Phoenix, A. T., Jan. 9.—In a drunken brawl, night-before-last, one Mexican shot and killed another. Coroner's jury decided it to be a case of justifiable homicide.

Tucson, A. T., Jan. 10.—A special messenger arrived Tuesday morning with news from Sonora, which is printed in the following form in the Legislative Journal: Two skirmishes had taken place—one 25, and the other 10 miles from Ures. In the latter, five of Pesquiera's men are reported killed, and a number of Gov. Pesquiera mortally wounded.

The people generally favor Mariscal. Capt. Douglas, of the Mojave, indisposed by his wounds, and will return, via Yuma, on the New Mexico.

representatives felt it in their bones, and transferred the Capital of the Territory from this Mexican pueblo, to Prescott—the largest American town in the Territory. For this, citizens of Prescott have to thank Messrs. Bull of Mohave, Scott of Pinal, Col. Woolsey and the other just and honorable men who represent Maricopa County. The Pima delegation, in the House, made no word of resistance to the passage of the bill; but, one of their Council members (Dr. Goodwin), had the bad taste and judgement to accuse Yavapai of wrong-doing in certain matters, Judge Rush, of our county, was not slow to answer the Doctor's tirade, and did it very effectively. The feeling will, no doubt, soon die out. Tucson cannot seriously think of ever again becoming the Capital of Arizona. I, for one, for the fearful position which they have committed in the past, and will not wait them with their deadness, in case they show a proper spirit.

A long hold on the Capital, the U. S. Department, Supreme Court, Secretary of War's office, Territorial money, and many other aids to development and progress have given the people of Tucson a very fair start in the world, and one which I hope will enable Yavapai to get along until such time as their mines and other resources of their section shall be developed. Their trade with Sonora is quite large, but not what it will be when that turbulent foreign State becomes pacified and put upon the track which leads to civilization and good government.

While Pima's politicians and money-grabbers profess to be satisfied with the new order of things, they are far from being so, as is apparent from the earnest manner in which they are endeavoring to strengthen Yavapai's position by introducing in the Territorial Congress for the amendment of Arizona of Grant County, N. M. Again, they are stirring up, and abetting, citizens of Yavapai to resist from last evening Pinal County, and planting other small mines, all of course, for the benefit of the Territory and town. But they will not get away with these schemes if Yavapai and her southern sisters can block their games.
