SUPREME COURT DECISIONS. [Filed March 6, 1891.] IN BANK. WOODY ET AL., Respondents, No. 14,470.

The plaintiffs gave evidence tending to show that they used the applications recommended by the defendants, and that the bunches were hereditary and irremovable. On these points the evidence is conflicting.

Now, even if it were assumed that the defendants could make the performance by plaintiffs of a separate and distinct contract a condition of the right of exchange, the fact was that there was no contract on the part of the plaintiffs in reference to a mare which was admitted at the trial.
