

SMITH HELD FOR TRIAL.

Conclusion of the Sensational Case in the Police Court.

Gordon, Another of the Allen Thugs, is Held to Answer Too—Brady Tells His Story.

The preliminary examination of J. D. Smith, the dive-keeper, charged with complicity in the robbery of Robert Allen, was resumed in the Police Court yesterday morning, and again the place was crowded almost to suffocation.

Smith has lost much of his careless air, and seemed to be more interested in the proceedings yesterday than heretofore. It evidently does not appear to be so much of a joke to him now.

Smith occupied a seat between his attorneys, Messrs. Hiram Johnson and Frank Estabrook. Gordon and "Piggy" Johnson were there, and the former, as usual, was the center of attraction. Brady, the informer, was there, too, and was the recipient of frequent dark scowls from Gordon and Smith.

City Attorney Hart conducted the prosecution. District Attorney Ryan and Police Captain Lee sat close to him and counseled with him.

The first witness called by the prosecution was Frank Johnson, "Piggy" Johnson. The witness said he was acquainted with Haley, alias Mitchell. He last saw him shortly after the Allen robbery. He saw him in San Francisco, on the afternoon of the 11th of May, witness had a conversation with Haley.

Continuing, Johnson said he sold the property, it consisted of a fob buckle and a Masonic chain. Upon being shown Robert Allen's buckle and chain, Johnson identified them as the ones given him by Haley.

BRADY'S STORY. Robert Mashett, who has been known as "Brady," was the next witness. He is the man who gave the police the first clue to the robbers, and is the man whom Gordon and Casey say they hit with the hammer with which to strike Allen.

Brady said he knew Gordon, Casey and Haley slightly. He also knew dive-keeper Smith, and on the Thursday evening before the Allen robbery, the witness saw Casey, Gordon and Haley in Smith's place. This was the only time he had ever seen them together.

On cross-examination the witness said that "Brady" was only his stage name. Fighting was his business. He said that he and Casey went to Galt to rob the ticket agent at that place. He also denied positively that he ever observed Gordon and Casey talking about the robbery, and that he joined in with them.
