Among the good things which can be credited to the late Legislature is the following revision of the game law.

Every person who, in any county of the State, at any time, takes, gathers or destroys eggs of any quail, partridge or grouse, or any other kind of game bird, summer duck, reedhead, teal, or any kind of gray duck, or any kind of wild duck, is guilty of a misdemeanor.

Every person who, in any of the counties of the State, hunts, pursues, takes, kills or destroys any male deer, antelope, pronghorn or buck for the same, within two years from the date of the passage of this Act, is guilty of a misdemeanor.

Wood-ashes are nearly always beneficial to muck lands, and occasionally they contain hastens decomposition of vegetable food, besides making phosphate also more valuable.
