PREVENTION OF CRIME IN YOUTH.

At the National Charity Conference held recently at Indianapolis, Mr. A. C. Wright, a conspicuous worker in the prevention of crime, submitted an able paper in which he contended that compulsory education is the best preventive of the enlargement of the criminal classes.

HOT WAVES AND HEAT.

They have had a hot wave at the East already, and our exchanges are filled with accounts of it. The New York Herald of the 10th speaks of it reaching that city on the Sunday and Monday prior, when the mercury went up almost to the one hundredth degree mark, and held to it, in the shade.

This is a remarkable record for June at the East. The Herald figures out, by some process of its own, prophetic and otherwise, that this premature experience means numerous other hot waves to sweep over the East this year.

At the very time when the people of New York, Boston and the whole northeast section were suffering so intensely, with the thermometer at 98° in the shade, it registered in the nineties in all the great valley regions of California, and even upon portions of the coast, as in San Francisco.


