

THE "NORRIS GRANT."

Farmers Disputing the Assessor's Valuation Thereof.

A Lively Session of the Board of Equalization--More Testimony to be Given To-day.

Yesterday was the day fixed by the Supervisors to hear testimony on the protests filed by J. E. Camp and John Rooney against the assessments made upon certain portions of the Haggin Grant.

The complainants own and cultivate bottom lands on the south side of the American River, east of Brighton, the Haggin property being on the north side of the river and opposite to theirs.

On the Haggin ranch there are several pieces of bottom or bench land along the river and below the high bluffs, these benches having been formed chiefly by changes in the course of the river channel.

The lands on the south side are all in a high state of cultivation, while only small portions of the benches and "islands" on the other side are put to more important use than pasturing stock.

NORTH AND SOUTH SIDE FIGURES. The south-siders are assessed from \$75 to \$100 for their orchard, hop, vineyard and alfalfa-growing lands, while on the north side 100 acres have been assessed at \$60 per acre, \$21 acres at \$15, and another \$60 acres at \$15.

Both sides were present in force yesterday, the Haggin interests being represented by Superintendent John Mackey. Considerable time was lost during the two hours of the morning session by wrangling between the contending parties relative to the method of procedure, and on several occasions some very sharp personal remarks and rejoinders passed between Messrs. Camp, Rooney and Bowles on the one side, and Mr. Mackey on the other.

It was decided that Mr. Mackey should first be sworn and catechized relative to the character of the Haggin land. He referred to the recent visit by the members of the board to the grant and their inspection of the portions under dispute, and said there were thirty-one acres which he was willing to have placed on the north side of the river.

Mr. Mackey's testimony was that the land was assessed the same as last year, when no complaint was made. He stated that the land was assessed at \$100 per acre.
