KENTUCKY AND THE LOTTERY. Kentucky for some thirty-five years licensed lotteries. She tried the experiment in all its fullness. Lotteries under the wing of that State were run in several of the chief cities, and no limit was put upon them beyond the percentage for charities that they paid to the State institutions.

It is certain, therefore, that the people of Kentucky know all about the lottery business, precisely its effect upon communities, just what can be said for a license system and all that can be advanced against it. With this intimate knowledge and long experience they went to the polls ten days or so ago, and voted upon the adoption of a new Constitution.

The seizure of a Pacific Mail steamer by San Salvador authorities may involve the Government in a serious dispute with the Central American States. The steamer was taken for departing from port without a permit. This she did because the authorities by refusal to permit natives to work in loading the ship at night, broke up her schedule time and gave undue advantage to her rivals.

The correspondent of one San Francisco paper writing from "all along the lines" in Chile, declares that unless the insurgents can muster 40,000 men well armed, they cannot even scratch the hide of the Government army; that Balmaceda is admirably equipped to crush the rebellion; that his army is loyal, strong, well armed and full of anxiety to fight; that the rebel forces are weak, poorly armed and disheartened; that, indeed, all indications point to Balmaceda's speedy success.

If he is a candidate for his party's nomination for the Presidency, the very worst thing he could do at this juncture would be to make a show of himself in Ohio, for the ex-President would certainly draw a crowd. But while he would be listened to with attention and respect, his engagement in a State campaign, such as is now progressing in the Buckeye State, would tend to lessen his chances before a National Convention. He is wiser to refrain and to

Until that does obedience to the doctors, neither Chautauquans nor other reformers need entertain hope.

THE NEW YORK Herald is alarmed at the increase of murders. It asks, "Is the penalty of the law for the crime too deterrent?" It proceeds to answer the question by saying, "Yes, when the punishment is inflicted with celerity, but it is the law's delay that shears the penalty of the terror it ought to inspire." That the Herald is sound in this expression is true. But that is not all; the penalty has been negative very much by the publicity and sensationalism of the executions. It is easily shown that the method of carrying into effect the judgments of the courts in murder cases, in most of the States, inspires very little fear--indeed, that it invites men of a certain grade to pose in a dramatic attitude, and that in consequence the scaffold has few terrors for the hardened classes. When, however, as is now done in New York, the execution is made rigidly private, sensational reports of it are prohibited, and all opportunity for the condemned to strike attitudes and invoke sentimental sympathy is cut off, the death penalty becomes truly deterrent. If the New York system is adopted in all the States we believe that the effect will be to greatly decrease the aggregate of murders in this country.

The seizure of a Pacific Mail steamer by San Salvador authorities may involve the Government in a serious dispute with the Central American States. The steamer was taken for departing from port without a permit. This she did because the authorities by refusal to permit natives to work in loading the ship at night, broke up her schedule time and gave undue advantage to her rivals. Indeed it is asserted that had the Captain not departed as he did, and refused to load certain goods which would have consumed too much time if handled only by daylight, he would have forfeited his mail carrying contracts. The action of the San Salvador authorities was petty, and deserves to be spoken of and acted upon by the United States Government with some severity. These little Central American States have very frequently taken occasion to air their limited authority to the detriment of our commerce. Of course the Captain of the steamer violated a port regulation, but not one of special importance, and it was seemingly a necessity that he should do so. The imposition of a fine he probably expected and was prepared to meet. He was between two dangers and chose the least, but his offense scarcely merited such a severe penalty as has been inflicted.
