EDMONDS IS DEAD.

The Victim of Sunday Morning's Cowardly Assault.

The Autopsy Shows That He Died of Concussion of the Brain--The Police Investigating.

Thomas Edmunds, the old man who was robbed and beaten by unknown persons in the alley near Second and K streets, early Sunday morning, died from his injuries, at the County Hospital, yesterday.

The police have left no stone unturned in trying to ferret out the perpetrators of the cowardly assault, but have so far been unsuccessful.

Dr. G. A. White performed an autopsy on the remains yesterday afternoon, and last evening made the following report on the matter.

"I have this day made an autopsical examination of the body of Edmund DeLaunay, aged 72 years, a native of Montreal, Canada. The deceased was admitted into the County Hospital on the 16th of August, at 7:30 o'clock in the evening.

"The autopsical examination showed that the head and face was very extensively bruised and contused, with effusion of blood underneath the skin. The incised wound upon the right temple was partially closed, as well as the scalp wound on the left side of the head.

"An old point of softening was found in the right hemisphere of the brain, above the third frontal convolution and above the fissure of Rolandi. This softened spot was confined to the gray matter of the brain, and was an inch in length by three-quarters of an inch in width, and contained granular matter mixed with watery fluid, showing that this condition was chronic.

"The deceased must have manifested symptoms of insanity at frequent intervals during his life-time, and prior to the receipt of the injuries received which are above described.

"Efforts have been made to learn where Edmunds' relatives are located, without success. It is thought he came from Portland, Oregon, and his last name is heard from that place concerning him.
