THE CLOSE OF THE FAIR. The thirty-eighth annual exhibition of the State Agricultural Society closes to-night. It has been an entirely satisfactory fair.

THE IRRIGATION CONGRESS AT SALT LAKE has completed its labors. It has resolved upon memorializing the Congress of the United States, with a view of having granted in trust to the States and Territories all unoccupied public lands except mineral lands upon conditions that will best conserve the public interest, for the purpose of developing irrigation and rendering lands now arid fertile and capable of supporting a large population.

THE INTERNATIONAL CONGRESS OF HYGIENE, held in London in August, Surgeon-General Cunningham read a paper declaring that of the three methods of preventing the spread of cholera, taking it as a type of epidemic disease, to wit: 1. By quarantine, 2. Medical inspection, 3. Sanitary improvement, the latter only is of real service.

INSPECTOR-GENERAL LAWSON read a paper on cholera transportation, in which he insisted that cholera cannot be kept out by quarantine, and that all that can be done is by hygienic measures to improve the health of the population and to remove the conditions favoring the formation of cholera.

DR. ASHBURTON THOMPSON, of the Australian Sanitary Conference, followed upon the same subject. He found more virtue in quarantine, but said that experience in Australia had demonstrated that quarantine could yield protection commensurate with its cost only in countries whose internal sanitation was good, and to lessen the entering number of the foci of infection.

DR. FELKIN followed in an address showing that among the White Nile and the darker African tribes preventive methods against cholera are common to arrest the march of the pest. They stamp it out by evacuating and burning their villages.

DR. STANKIVS of Australia agreed with Surgeon-General Cunningham as to ineffectiveness of quarantine, as also did Sir Joseph Fayrer.

atmospheric currents for great distances. It pauses and becomes malignant in those localities where the unsanitary conditions are inviting. The duty of communities, therefore, to make their localities clean, pure and, in a sanitary sense, perfect, is spurred by the knowledge that insidious conditions means invitation to malignant epidemics.

SECTARIANISM AMONG DOCTORS. That medicine is becoming more and more a liberal study, and that its practice is becoming more and more broadened and liberal cannot be truthfully denied. It is in evidence and within our own knowledge that distinguished physicians of the regular school do not hesitate when the need is, to use the agencies of a rival school of medicine generally stigmatized as irregulars.

Though it is now well known that many physicians employ methods in treatment of disease that are distinctively those of rival schools, we hear no more of attempts to "church" these liberal practitioners. We have now the authority of the American Lancet for the statement that after the distinctive organization of the homeopaths in New York, some of the old school doctors desired to consult with the new. They were resisted by their fellows, and the result was that the rebels captured the New York State Medical Society and set up a liberal code, very elastic as to consultations. Those who would not recognize such a code formed a new State society and it still exists, the most powerful one in the land.

"However," says the Lancet, "the new doctrine, with New York as a center, spreads. Its influence can be seen anywhere. In every city consultations of regulars and irregulars is said to be a common occurrence. In Detroit the Homeopathic Hospital is filled largely with the patients of regular physicians. The carriage of the two sects alternate upon the adjacent streets during regular visiting hours. The Montgomery, Ala., Medical Society has unanimously adopted resolutions favoring consultations with homeopaths and eclectic. The relations already existing between these practitioners in that State are such that it is no wonder this result follows. All this in the home of the late Dr. Baldwin of Montgomery, the stalwart opponent of such consultations! Columbus, Ind., has formed a Medical Society, in which all physicians meet on one common plan. It is reported that that staunch friend of the medical profession, Dr. T. A. Reany of Cincinnati, spent an evening with this society."

The Medical Record finds in this liberal tendency nothing over which to grieve. Though a "regular," its editor believes the tendency to be a good one and its results beneficial. He adds that we are getting better physicians and more honest ones every year; that sectarianism is disappearing and is bound to be abolished entirely. The test of a man will be his education, his moral worth and his practical skill. In short, the Medical Record believes that if a man has a fid or dogma in the hearing art, he should be given a fair show, time proving how much value to be attached to his views and methods.

VISHER'S COMPLAINT.

The Supreme Court Says it is Poorly Drawn, But Will Do. A Supreme Court opinion in the case of P. Visser (plaintiff and appellant) vs. J. V. Smith and H. E. Wright (co-defendants) was filed yesterday in the Deputy Clerk's office in this city. The complaint substantially alleges that the defendants were engaged as copartners in the business of warehousemen in San Joaquin County and as such doing a general storage business.

Visser stored 1,040 sacks of barley in the warehouse, and when he wanted to remove it the defendants refused to deliver the barley without giving any excuse or reason therefor. Visser had offered to pay the storage and surrender the receipt upon the delivery of the barley.

He demanded judgment for the recovery of the barley or for \$1,350, the value of the same. The complaint was demurred to on the ground that it did not set out facts sufficient to constitute a cause of action. The court sustained the demurrer, and upon Visser's refusing to amend his complaint final judgment was rendered in favor of the defendants. The case was appealed on the judgment roll alone.

The Supreme Court says: "While the complaint is not in all respects as artfully drawn nor as precise and direct in its statement of facts as it might have been, and while there are many defects of form that could have been taken advantage of by special demurrer, still, upon the facts stated, we are of the opinion that the complaint is sufficient to constitute a general demurrer. We therefore recommend that the judgment be reversed, with directions to the court below to overrule the demurrer."

Police Court. Five minutes' time was all that Judge Graves required yesterday to run through the Police Court calendar. P. Coleman was sent to the City Prison for fifteen days for being drunk, and one of the Doe family got five days for a similar offense.

G. H. Brown and James T. Bailey, who visited the county in that order, were arrested by the police for disturbing the peace against J. V. Coffey was dismissed on motion of the City Attorney.


