DR. C. B. NICHOLS, Health Officer—DEAR SIR.

I have examined the orphan asylum on L street, between Eighteenth and Nineteenth, and find the following plumbing fixtures now in use:

Two plug bath tubs and closets, one Kelly closet, one bath tub and three sinks, also the building will occupy and a sink to child in the room of the bathroom.

The plumbing is an old-fashioned, not properly vented, out of repair, and in every instance in direct violation of the plumbing laws of this city.

The bathroom was a large pool of water, caused by the leaking pipes from the fixtures above, and was still leaking when I left.

The joints are loose and have holes in them, so that children playing around them inhale the foul gases; also, a four-inch sewer pipe left open under the porch.

In consequence of the unsanitary condition of the whole system, I am compelled to condemn it as dangerous to the health and lives of the occupants of the house, and recommend that you take immediate steps toward removing the present system of plumbing and put in a new one, in accordance with the rules and regulations of the Board of Health and city ordinances, thereby putting the building in such a sanitary condition that it will be safe for those now occupying it to remain there.
