

THE REGIMENTAL TROPHY.

Proposed Changes in Overland Time Schedule—Twelve New Pullmans.

There is talk in railroad circles in San Francisco of prospective changes in the overland time-tables on May 1st.

The fast mail, which has hitherto arrived there at 11:45 a. m., will arrive at 9:15 a. m.

Of the two and a half hours' saved time, one and a half will be saved between Ogden and that city.

The evening overland west-bound instead of arriving as hitherto, at 10:45 p. m., will reach that city at 9:45 p. m., making up one hour between there and Ogden.

East-bound trains will leave at the same time as heretofore, but will gain time between San Francisco and Ogden, making better speed and closer connections with both the Union Pacific and the Denver and Rio Grande at Ogden.

The Husband Now Sues the Wife for a Legal Separation.

Franklin H. Coffman commenced suit against his wife Susie J. Coffman for divorce, Saturday, in the Superior Court.

The couple have gained considerable notoriety through their troubles. Mrs. Coffman sued her husband for a divorce some time ago but he opposed the suit and the desired decree was not granted. But the court ordered that Coffman should pay \$25 per month for the support of the three children who were given into the custody of the wife. Coffman claimed he could not pay this amount, and was ordered to pay it. But before the Sheriff could lay hands upon him he disappeared, and was not seen for several months. Returning finally, Coffman agreed to pay \$25 per month, and the offer was accepted. It is understood, also, that Mrs. Coffman will not oppose the suit for divorce.

WEARY OF JAIL.

Daniel Gardner Wants to Get Out for a While on Bail.

Daniel Gardner, the aged wood-merchant who was sentenced to six years' imprisonment at Folsom for criminal assault on Lizzie Cox, was brought to this city a couple of months ago, to remain while his case was appealed to the Supreme Court. He was admitted to bail for \$10,000, but, not being able to furnish it, has remained in the County Jail.

On Saturday Gardner's attorney, S. S. Holm, made application to Superior Judge Van Fleet to have the old man's bail reduced to \$1,000 cash or a \$5,000 bond, so that he might be liberated pending the appeal.

The court took the matter under advisement and may decide to-day.

Charles Weiger, the dry-goods dealer whose place of business was recently closed by virtue of an attachment suit commenced by one of his San Francisco creditors, filed a voluntary debtor's petition in insolvency in the Superior Court Saturday. His assets consist of a stock of goods at 519 1/2 street, book accounts, and all of which are in the possession of the Sheriff.

IN CUSTODY AGAIN.

Erratic Fred George Once More Before the Lunacy Commissioners.

He Cuts a Wide Swath About Town, But Talks Rationally to the Doctors.

Fred L. George, the erratic young man who was declared sane by a jury in the Superior Court last week, and released from the Stockton Insane Asylum, was hauled up before the Lunacy Commissioners again Saturday.

Since his release George has been cutting a wide swath with what money he has been able to get out of his estate. He dressed himself up in bright blue naval uniform, low-tailed suit, ornamented with brilliant buttons, donned a plumed hat, drove around town in a hack, ordered a gold-mounted rifle with diamond sights, tried to purchase \$2,000 worth of lottery tickets, bought innumerable costly presents for the fallen angels of L street—and cut up all sorts of similar dicos.

George's father became alarmed, and going to the Police Station beseeched Chief Rodgers to have the young man taken into custody again. The father said that Fred had taken a gold watch which was given to him by his mother on her deathbed, and given it to a lower class woman, who had been seduced by a Rider recovered the watch. The woman admitted that George had given it to her. He had taken it to some jeweler and had a skull and crossbones engraved upon it before presenting it to her. He had also presented her with three handsome manure sets, one of which was a gentleman's, consisting of a hat, a cane, a mug, and other similar paraphernalia. These were also taken possession of by the officers.

When George was taken before the Commissioners late in the afternoon all of these facts were presented.

The only time during the examination that the young man's talk indicated a disordered mind was when he related his experiences in the "bug-house," as he characterized the asylum at Stockton. He insisted that all of the doctors there were crazy, and stated that he had his assertion that their favorite prescription there was carbolic acid. He said the asylum was full of sane people and he intended to go back to the city.

"I'll just tell you what it is, gentlemen," said George at the conclusion of his examination, "don't want you to send me back to that bug-house. If you do it will only put me to the expense of getting out again. My attorneys charged me \$35 for this last time."

"Did you pay them?" asked Judge Catlin.

"No; I gave them a mortgage on some of my property. They got another mortgage on me, but I can prove that I never signed it."

Drs. C. B. Nichols and G. L. Simmons, who, with Judge Catlin, formed the commission, held a consultation after the examination. They did not believe the evidence furnished was sufficient to warrant returning George to the asylum, and finally postponed the case until to-day for further examination. George was kept in the County Jail.
