THE LEVEE QUESTION.

It is amazing that the City Trustees should refuse to submit the question to the people whether they wish the levees raised, broadened and improved thoroughly or not. The submission could be made, for economy's sake, without cost; at least for a song. It is not necessary that a legal test of public opinion be made—let the Trustees relieve themselves wholly of responsibility by ascertaining the will of the people.

Thus there has been a larger export trade and a larger import trade at the port of San Francisco than for the year 1891. The Examiner is authority for the statement that in 1891 the shipments of barley from the State were more than double the quantity exported in the previous year, and that the movement in the past six months was much larger than recorded for the similar period in several previous years.

The Examiner goes on to say that the salmon trade has been unusually active, the value of the exports by sea for the past six months having been \$1,066,667 as against \$678,967 for the same time in 1891 and \$697,700 in 1890. The Examiner is also authority for the statement that the fruit-growers of Yaca Valley claim that this is the best year they have ever known. They quote the testimony of Thomas Wilson, a well-known citizen of Yacaville, in this connection.

Yet it would appear from the statements of the Mayor that he deems the levees safe with a little patchwork. Does he wish to assume the attitude and responsibility of this statement implies against the positive statements of engineers who spent twelve years in official study of our rivers and their levees, and who flatly and emphatically contradict him? If he is willing, the people are not. They prefer the opinion of C. E. Grunsky to that of his honor the Mayor; the judgment of Captain Roberts to that of Mr. W. D. Comstock; of Wm. Ham. Hall to that of the First Trustee, in matters of engineering and protection by levees.

So, too, it would appear from the statement of Mr. Trustee Green, the new Street Commissioner, that everything will be beloved if there is some work done on the front line of levees. This was supplemented by the astounding statement that the Street Commissioner deems the point of danger to be upon the front line, from Seventh street, back of the railroad shops, south along the business front. The value of this judgment can be estimated by those who know that part of the section is solid ground a half mile broad, levee high; in fact, is as thick as the city high grade on I, J, K and L streets, and that what the thick section needs is raising to counteract the bad moral effect of water standing on top of the ground, and to broaden the levee where above street grades, and possibly to riprap it.

The question of systematic, thorough improvement is greater than these gentlemen have any conception of. It may involve dangerous industrial cessation; inactivity of capital, declination of faith, manifest by withdrawals of business; depreciation in realty values, and so on.

This business has got beyond the patience point; it is no longer one of sentiment or opinion or dollars, but of actual, immediate, undeniable necessity. We cannot induce manufacturing ventures, large construction, further investment, enlarged and new industries, or reinforcement of population by immigration, under present conditions. We may not only lose what we have that we cherish, but never replace the loss.

Let water flow on the levee tops another season because of official stubbornness, and those lying in wait for the occasion to pounce upon Sacramento and wrest from it institutions it has will have their opportunity, improve it and succeed, despite the opinions of that estimable citizen, Mr. Comstock, and that new broom, Mr. Green. In fact, should disaster overtake the city, because of refusal to permit the will of the people to

dominate, those gentlemen would invite anathema no good man provokes.

Forty millions of values in Sacramento ask the privilege of expending on twenty years credit about \$100,000, to be home advanced, in protective works that will absolutely secure them against all possible river assault; but the Trustees refuse, and propose to substitute \$7,000 or \$8,000 of patch work. That is all there is of it. It remains for the people to submit and take the chances—but will they?

SLANDERING THEIR OWN HOMES.

The newspapers of San Francisco have reported that there are from seven to eight thousand empty houses in that city awaiting tenants. Inquiry by a representative of this paper at the Spring Valley Water Works ascertained that there were less than 1,500 vacant taps. The statistics of the water works of the city show that the vacant taps for this year are but little more than nominal. They show a falling off of new taps, but no unusual state of affairs as to the number of vacant houses. The number of vacant taps is about 1,500, but as many of the taps represent compartment houses, with four and six flats, the number of vacant tenements is something less than 2,000. The papers of San Francisco have been declaring that the trade of that city is falling off; that everything was going to the bad.

And now comes the Examiner to say that the statistics published in its commercial columns show that for the year ending June 30, 1892, the total shipments of wheat and flour from San Francisco were valued at \$27,943,647—a much larger value than recorded for any previous year in a long time. It further shows that the speculative transactions in farm produce in 1891-92 were larger than during the two preceding years, as shown by the records of the Produce Exchange Call Board. It further declares that the customs duties collected on foreign imports during the past six months were \$117,406 more than for the same time in 1891.

Thus there has been a larger export trade and a larger import trade at the port of San Francisco than for the year 1891.
