



BRAZIL REVOLUTION.

Rumor That the Insurgents Have Captured the City of Rio.

ALSO THAT PEIXOTO HAS RESIGNED IN FAVOR OF MELLO.

The News Discredited in Washington and London Official Circles Owing to the Receipt of No Dispatches Confirming the Report—Severe Engagement Between Insurgents and Government Troops at Itajay, in Which Four Hundred Were Killed and a Large Number Wounded.

PERNAMBUCO, Dec. 22.—Startling rumors have reached here from various sources, which lend an air of credulity to them, to the effect that the insurgent fleet at Rio de Janeiro, after two days' desultory fighting, made a determined attack in force and captured the city. It is added that President Peixoto has resigned in favor of Admiral de Mello, and that Peixoto is a prisoner. Though this is general rumor, it is right to add that the people of Pernambuco do not credit it.

The Associated Press correspondent was unable to obtain a reply to messages sent forth, and messages from the Associated Press correspondent at Rio are apparently intercepted, lending color to the belief that something extraordinary has happened.

A battle between the rebels and Government forces is reported to have been fought yesterday in the interior. Fifty Government troops are said to have been killed.

NOT CREDITED AT LONDON.

LONDON, Dec. 22.—The news that Rio de Janeiro has surrendered to the insurgents are not credited here. Inquiry at the office of the Eastern Telegraph Company elicits the information that cable traffic with Rio is progressing as usual, and nothing has transpired to indicate that any important change in the situation has occurred.

The reported capture reached this city after the close of business hours. The Brazilian Minister said that the last cable message received from Rio was on December 20th, when the Minister of Marine said all was right.

NO OFFICIAL NEWS OF CONFIRMATION RECEIVED AT WASHINGTON.

WASHINGTON, Dec. 22.—Neither in official nor diplomatic circles has any word been received which confirms the rumors that Rio has fallen and that Peixoto has resigned and is a prisoner. The belief among officials and diplomats is that the rumors are premature, to say the least. No such information has been received from Captain Pickens, in command of the United States forces in Brazil, and this is considered as showing that the Pernambuco rumors are not true. Department officials do not believe they would be kept in ignorance of such important events as the overthrow of the Government and the capture of the President.

At the Brazilian Legation no cables have been received since the departure of Mendoca for New York last Wednesday. Dr. Zeballos, the Argentine Minister, says Buenos Ayres is the New York of South America, and he is endeavoring to know of such important results as rumored in Brazil. He has received no advice, and doubts the report. He says he and Charles R. Smith, the Argentine minister, were very busy and could not be interviewed regarding the situation in Brazil. He also asserted that the Argentine news that Rio had fallen into the hands of Mello, the Brazilian Consul, seen at his office, discredited the report that Rio had fallen.

SEVERE ENGAGEMENT AT ITAJAY.

Buenos Ayres, Dec. 22.—A severe engagement between the Brazilian insurgents and Government troops is reported to have taken place at Itajay, north of Breston. It is said 400 were killed and a large number wounded. The Government is said to have captured the rebel warship Madro.

GOVERNMENT TROOPS PRESSED IN.

New York, Dec. 22.—A Herald Montevideo special says: News has been received of a fight which began Wednesday between Government troops and insurgents. The Government troops, under General Saravia's men joined with those under Salgado, making a total of 8,000. The fighting place is Itajay, the insurgent division being that of the Argentine, under the command of the late General Saravia, and the latest reports the rebels lost 400 men, but had the Government troops so badly penned in that surrender seemed unavoidable, when the rebels were armed, having lately received many rifles and guns brought from Rio on board the Aquidaban.

The Republic is taking on coal and is almost ready to sail. It is rumored she is coming to Montevideo to fight Peixoto's squadron gathering there.

One of Mello's lieutenants, the Meteor, is ashore at Barra Itajay. While she was reconnoitering the harbor entrance she ran aground, and the Government artillery there, with three machine guns, opened fire upon her and kept up the cannonade until all the crew were killed.

FRENCH ANARCHISTS.

Violent Manifesto Issued Threatening Vengeance. PARIS, Dec. 22.—The Associated Press has obtained a copy of a violent manifesto which the French anarchists of London have secretly prepared for distribution in Paris. The manifesto is headed "Dynamitards to the Panama Crew."

The manifesto says: "This, the first dynamite explosion, will not be the last for you wretches. Since 1871, when you converted Paris into a charnel-house, and massacred 30,000 proletarians, the republic has been torn by the anarchists, directed successively by the scoundrels Thiers, the brute MacMahon, the thief Grey and the mankin Carnot, while the poor have been reduced to the condition of white slavery, or die of starvation in the streets. Do you think such things can endure? No! revolution will devour you. We, whom you outlawed, will come to the rescue of the starving and thumped poor, who cannot wait patiently, like the labor deputies, so-called because they had no work. These idiots and renegade deputies declared recently that you would have them shot like rabbits, but they decline to be blown up with you. Don't hold the miserable socialists responsible for dynamite. They only want to enrich themselves, like you."

A MADMAN IN A THEATER.

Terrible Tragedy Averted in a Salt Lake Playhouse

BY THE PROMPT ACTION OF MEMBERS OF THE COMPANY.

SALT LAKE, Dec. 22.—By the presence of mind and prompt action on the part of several members of a theater company, a terrible tragedy was averted at the Salt Lake Theater this evening. About 9 o'clock Oscar B. Young, a crazy son of the Mormon prophet Brigham Young, burst open the door of the theater box-office. Before astonished Treasurer and Manager could collect themselves, Young strode into the theater, around to the stage door and dashed across the stage. The curtain was down and the actors were dressing for the second act. In the first dressing-room he broke and stood frothing in passion before Harry Connor. After trying to lock the door he demanded the key of Connor. "I'll teach you to go to New York and talk about Danies," he said.

With a torrent of oaths the madman pressed upon Connor. Instantly recognizing that he was in the presence of a madman, Connor gave a quick leap out of the room. The ladies in the adjoining rooms screamed.

At this moment propertyman Antonio Mazzanovich, a match in strength and size for Young, leaped upon the madman from behind and pinioned him. Just then a boy was passing with two swords used in the play. With a strength born of madness, Young released himself, grabbed a sword, and commenced plunging at those around him. Again the massive propertyman caught him from behind, and at the same time catching the hilt of the sword. Those ladies who had not fainted rushed to the room. "Don't lynch me, don't lynch me," cried Young. He was forced into the street by a policeman called, and still raving, he was carried to the station.

Young has long been regarded as daff, and of late has shown dangerous tendencies. Those who know the man regard the lucky overcome in the stage encounter as little short of a miracle.

Young's present spell is said to be the result of financial troubles. He had no acquaintance with anyone of the theater company.

CHINESE SMUGGLERS.

The Case at Portland Given to the Jury—The Judge's Instructions.

PORTLAND (Or.), Dec. 22.—The trial of twenty persons in the United States District Court on a charge of conspiracy to smuggle Chinese into the United States from British Columbia came to an end, and the case was given to the jury at a late hour. Judge Bellinger ordered the jury to return a sealed verdict if they agreed before morning. The judge instructed the jury to return a verdict of acquittal in the cases of Captain John Ross, J. S. Martz and Glen O. Holman. His instruction in the cases of the ten Chinese merchants was virtually to acquit the defendants. The cases of James Lolan, L. J. Mulkey, Thomas Jordan, P. J. Bannon, Seid Yooker and Ching Quing were left to the judgment of the jury. The trial occupied two weeks, and over 100 witnesses were examined.

The New Freight Tariff.

SAN FRANCISCO, Dec. 22.—J. C. Stubbs, Third Vice-President of the Southern Pacific, says the new freight tariff which goes into effect January 1st will make a reduction of 5 per cent. There will be an advance in the higher grades, but most of the import products will in some cases be reduced 15 per cent. Fruits and farm products will experience a general advance. Manufactured articles will not be greatly affected, and there will be no change in the rate on wheat and other grain.

Wool-Growers' Interests.

SAN FRANCISCO, Dec. 22.—A meeting of the Wool-Growers' and Wool-Dealers' Protective Association was held here today. It was decided that a meeting of all interested parties should be held in San Francisco on January 10, 1894, for the purpose of protesting against the removal of the duty on wool and the lowering of the duty on woolsens, as provided by the majority report of the Ways and Means Committee.

Want a New Federal District.

FRESNO, Dec. 22.—At a meeting of a number of members of the Fresno Bar last night steps were taken looking to the establishment of a Federal District, embracing Fresno and several other central counties. Ex-Judge J. P. Strother was chosen Chairman of a committee appointed by himself to look after the drafting of resolutions to Congress. The other members are L. C. Cary, George L. Warlow, Dr. Rowell and Judge W. J. Tinnin.

MANY LIVES LOST.

Disastrous Cave-in at the Carnegie Mills, Near Homestead.

AT LEAST FOURTEEN PEOPLE SAID TO HAVE BEEN KILLED.

A Raco War Breaks Out in New Mexico, in Which Five Americans and Nineteen Mexicans are Killed—Unsuccessful Attempt to Hold Up a Train in Indian Territory—The Robbers Being Foiled, Open Fire, Seriously Wounding One of the Trainmen.

PITTSBURG, Dec. 22.—245 A. M.—News has just been received here by telephone from Homestead that a disastrous cave-in has occurred near there in the new addition to the Carnegie Mills. Fourteen men are said to have been killed and others seriously injured. The accident happened shortly after 1 o'clock this (Saturday) morning, but it was 2:35 before the news reached this city. No particulars had been received up to 3:45 A. M., and very little is possible, as the telegraph and telephone offices are closed and there are no trains moving at this hour.

THE UNION PACIFIC.

Many Plans for Its Reorganization in the Air.

OMAHA, Dec. 22.—General Solicitor Thurston of the Union Pacific, in speaking of the scheme of reorganization, said: "There are many plans for the reorganization of the Union Pacific property in the air. The general scheme, however, that seems to meet with the most favor is that the Union Pacific proper, together with those lines with a more properly a part of the system, although classed as feeders, shall be reorganized under Congressional authority. The other lines, under direction of the court, the sale is absolutely necessary, that the new company be formed that will permit a fresh start for the Union Pacific. The property would be able to pay interests on the obligations and the principal on the Government debt, so that Government security would grow constantly less. Should the Administration disapprove of some features of the theory of reorganization, the Government would discuss it over again. The rights of the Government must be sacredly guarded, as well as the rights of individuals, and this requires no inconsiderable time."
