

PURE POLITICAL WATER.

How Trustee Devine Carries on the Campaign.

He Charges Trustee Pennish With "Falling Down" After Making a "Deal."

Whenever the clear water proposition comes up Trustee Devine takes occasion to declare that there is a "job" in it and to denounce everybody who favors it as corrupt.

When a man continually charges other people with being dishonest he ought to conduct himself as to be above suspicion.

A little incident which is said to have resulted from the proceedings at the meeting of the Board of Trustees Monday night puts Mr. Devine in a very unfavorable light before the public.

At least two members of the Board of Trustees have stated to a representative of the Record-Union that on the day after the meeting Trustee Devine, in the presence of five members of the board, stated that he had entered into an agreement with Trustee Pennish that he would vote for the confirmation of Mr. Pennish's brother as policeman if Pennish would vote with him every time to defeat the clear water contract.

What do the people think of this state of affairs? There is an appointment of the Mayor confirmed by a majority of only one vote, which Trustee Devine declares he cast because of an agreement with Trustee Pennish that in consideration of that vote he would oppose the water contract which was entered into by direct instructions of the people, who voted in favor of it by an overwhelming majority.

MAKING PREPARATION.

Arranging for the Reception of the Republican State Convention.

The Citizens Executive Committee in charge of preparations for the coming Republican State Convention held a long and interesting meeting last night, General Reichert presiding.

C. H. Holmes was added to the committee, the plans of Architect Seadler for the arrangement of the Pavilion were adopted, with some modifications, and the Hall Committee was given power to proceed with the work.

The hall will be the rotunda, or central space of the Pavilion, which will be enclosed on three sides and seated for about 2,000 people. It will be handsomely decorated and made altogether beautiful and convenient.

A great deal of business concerning a multitude of details was transacted, which in the very nature of things cannot be reported and is not of general interest, as yet, as most of the business done is still dependent upon the work and reports of sub-committees.

It must suffice to say that nothing is being overlooked that will tend to the comfort of guests and the credit of the Capital City.

Elsewhere the Hall Committee gives notice of the desire to receive certain bids for fitting up the hall.

BRAVE LEN HARRIS IS DEAD.

Laid Low by the Bullet of a Desperado.

A Sacramento Pioneer and Officer Who Never Flinched From Duty—His Adventures.

The news of the shooting of Len Harris, the veteran detective, which appeared in the Record-Union's dispatches yesterday, was received in this city with expressions of sincere regret, and throughout the day numerous inquiries were made at this office for information as to his condition.

At 1 o'clock this morning the sad tidings came that he passed away a few minutes before midnight at the home of his daughter in Alameda.

Mr. Harris was in his 67th year, but up to the time he was shot by train robbers at Ceres, Stanislaus County, three years ago, he was as vigorous and active as most men of 40. Of course, in persons of such advanced age the recuperative powers are greatly lessened, and this fact, in connection with the injury he sustained at Ceres, told against him.

Len Harris was one of the bravest and best peace officers that ever wore a badge. Thirty-five years ago he was Warden of the County Jail in this city, and has ever since been employed either as a Deputy Sheriff, State Prison guard, police officer or detective for the railroad company.

He had been in many very tight places, but no one ever heard of his quailing before a foe.
