

PLUCKY YOUNG LOUIS BRUMAN.

He Climbs a Mile Uphill With a Bullet Through Him.

Terrible Hunting Accident on the Rubicon--An All-Night Journey to Placerville.

If Louis Bruman survives the wound received by him on Friday morning last, while hunting in the Sierra Nevada, and the rough journey he was obliged to undergo to reach this city, he will be a very fortunate young man.

Bruman's home is at Michigan Bar, where his father, Charles A. Bruman, is an old and well-known citizen.

The young man was alone at the time, but with wonderful grit and nerve he set out to reach the camp.

He rested his rifle against a rock, and while he was engaged in lacing his shoe the weapon fell and struck him in the head.

The bullet entered his abdomen, inflicting a wound that would ordinarily prove fatal.

The day being hot, they concluded to take a plunge in the river, although none of them could swim.

Brannan got out beyond his depth and went down. One of the others tried to help him and barely escaped sharing his fate.

Brannan was about 25 years of age, and was well liked by his employer and those associated with him.

He was from San Francisco and lived, it is thought, on Brannan street. Grappling hooks were brought into requisition, but at last accounts his body had not been recovered.

Signal Corps Boys Try Long Hellograph Work--Fourth Success.

The Signal Corps, Fourth Brigade, N. G. C., Lieutenant F. L. Martin in command, went up to Folsom early yesterday. It has a pride to achieve the honor of operating the longest hellograph stretches in the State.

FRUIT FOR LONDON.

The Third Special Train Dispatched This Morning.

The third special fruit train, consisting of ten carloads, was shipped from here at 2:40 o'clock this morning for the East, en route to the English market. The shipment is made by the California Fruit Transportation Company.

D. Z. Anderson, one of the largest growers in the State, ships two cars, one of plums from San Lorenzo and one of pears from Danville. F. L. Buck ships two cars of peaches, pears and plums from Vacaville; C. W. Reed, one of pears from Yolo; the Florin (Sacramento County) Fruit-Growers' Association, one of peaches, pears and grapes, and A. T. Hatch of Suisun two of pears. Two cars were shipped from Loomis--one by the Co-operative Fruit Company and the other by the Loomis Fruit-growers' Association.

A large proportion is shipped by the English colonists there, who take a great interest in the scheme, and whose shipments contain many packages sent to their friends at home, consisting of the finest fruits they have raised.

The first trainload that left here on the 4th inst. should arrive in London about Wednesday, and the news of its arrival is eagerly looked for. It is expected that the shipments will be kept up for the remainder of the season.

AURORA BOREALIS.
