

RECEPTION TO GOVERNOR BUDD,

Given by the Officers of the Fourth Brigade, N. G. C.

The Commander-in-Chief Expresses Solicitude for the National Guard - A Social Evening.

Brigadier-General T. W. Sheehan and the other officers of the Fourth Brigade, N. G. C., gave a reception to Governor Budd at the armory last evening.

The quarters of Light Battery B were artistically decorated for the occasion. The Governor's party consisted of Adjutant-General C. A. Allen, Assistant Adjutant-General Robert E. Murray, Private Secretary Colton and Executive Secretary McCabe.

Extended remarks were made by General Sheehan relative to the National Guard, also by Lieutenant-Colonel H. Weinstock.

RESCUED FROM A LIFE OF SHAME.

The Salvation Army Sends a Girl to Its Home.

Myrtle Reese's Sad Recital—Left an Orphan, She Falls Into the Maelstrom of Sin.

One of the saddest of the many leaves from life's history that are daily read in the Police Court was that which told the story yesterday of Myrtle Reese, a young girl accused of vagrancy.

The girl, who is some 17 years of age, was early deprived of the restraining influences of parental authority by the death of her father and mother. She was adopted by a worthy couple who resided in Portland, Or., and from earliest infancy had her every possible wish gratified, for the reason that she was a motherless child.

When she reached the age of 16 years her adopted parents also went over to the great majority, and Myrtle was received into the home of an aunt, who resided in the city of Oakland. Here the same mistaken kindness was accorded her. She was allowed every liberty, and her steps easily strayed from the path of virtue.

The downward path was rapidly traveled, and within one short year she tasted the bitter drags of life's cup by being taken before the Police Court charged with being the consort of creatures of the lowest grade of humanity.

There was such an absolutely forsaken, appealing expression in her pretty brown eyes, as she stood up in court to answer the charge of being a vagrant, and such a total lack of that brazen demeanor that so characterized the more hardened of fallen women, that the sympathies of Justice Davis and City Attorney Brown were enlisted in her behalf, and after learning the history of her life they concluded that she had been more sinned against than sinning.

Then the question arose as to what disposal could be made of the girl that would afford her a chance to regain her position in the world, which she so earnestly professed to be her desire.

Eastern cities have their reformatory, Magdalen Asylums and homes for fallen women, but, unfortunately, our city, with all its benevolent institutions, has no place where a poor girl can be absolutely excluded from the temptations of every-day life and the evil designs of the unprincipled scoundrels who prey upon and derive their means of existence from unfortunate women.

The matter was brought to the notice of a RECORD-UNION reporter, who immediately suggested that the facts in the case be laid before the officers of the Salvation Army. This was agreed upon, and he obtained an interview with Mrs. Captain Taylor and related the girl's sad history.

Mrs. Taylor said: "I thank you heartily for bringing me the information of this case. We are constantly in search of opportunities to alleviate the sufferings of mankind, and lend a hand to the fallen.
