

THE DISPOSAL OF SEWAGE

Mayor Hubbard Wants a Pumping Plant Near the River.

His Suggestions Are Contained in a Message to the City Trustees Last Night.

Mayor Hubbard realizes the necessity of the city disposing of its food waters and sewage more effectively than under the present inefficient and expensive method.

He suggests that the city secure the necessary ground on the river front, at the foot of S street, and there erect the proper kind of plant to meet its requirements.

A SIMPLE PROPOSITION. To the Honorable Board of Trustees: I feel satisfied that every member of your board has concluded that we must now take some positive steps toward securing a permanent pumping plant, and one that will remove the sewage and flood waters so that all portions of our city will be free from damage from this cause in the future.

The pumping plant now in operation was never intended to do this work, as you all know it is not one-quarter of the capacity required. It is a very simple proposition to arrange for such a plant as will meet the requirements of the case.

The question for your board to consider is as to where this pumping plant should be placed. In my judgment, the plant should be placed at a point where the sewage naturally flows. Three points have been suggested by the engineers who have investigated this subject, and are as follows: Sixth and S streets, Front and Y streets and Front and S streets.

It is important that your board decide as to what kind of a pump will be the most economical, and whether steam or electricity shall be used to operate it.

I would now suggest that you first secure a strip of ground 80x300 feet at the extension of S street, from Front street to the river. This property is claimed by W. R. Knights & Co. and also by the city of Sacramento, but as to which has the better title is a question which yet remains to be decided.

The next step for you to take will be to advertise for bids for a pumping plant, said plant to consist of a pump with a capacity of, say 20,000 gallons per minute, with engine, boiler, suction and discharge pipes, all to be placed in position and ready to operate, and said plant to be covered with a corrugated iron house; bidders to furnish the plans and specifications with bids.

This pump, having a capacity of say 20,000 gallons per minute, would be capable of removing more than three times the amount of water that the present pump can do under the most favorable circumstances.

When this plant is in position, with the sump and sewer so constructed that the flow will be directed to this station, you can then discontinue the plant at Eighth and Y streets.

In the new edition of "Doctrine and Covenants," a collection of Joseph Smith's so-called revelations, edited 1891 (see section 130, page 461, verse 15), Smith says: "I was praying very earnestly to know the time of the coming of the Son of Man, when I heard a voice repeat the following: 'Joseph, my son, if thou livest until thou art 85 years old thou shalt see me, the Son of Man.'"

It seems to me that such a plant would be sufficient for this city, even if the population should double; it would remove the sewage and flood waters so rapidly that the sewers would be cleared of all obstructions, and all parts of the city could be kept free from any accumulations of water, even during the heavy storms. With such a pumping plant established, our present system of sewers could be extended from time to time, as found necessary, and repairs could be made in some of the present sewers which would give them a better outlet.

Having studied the sewer system of this city carefully, I believe that if such a plant can be established to dispose of the sewage and flood waters, as described above, there will be no cause for complaint by the property owners, and that there will be no necessity for issuing bonds to do this work.
