VOICE OF THE PRESS.

Expressions of Interior California Newspapers.

Comments Upon Things Local, Governmental, Practical, Theoretical and Current.

Oakland Tribune: Word comes from Southern California that the Eastern market for oranges has so greatly improved recently that fruit exchanges have raised the price for citrus fruits. It is now within a week of March, and less than half of the orange crop has been shipped to market. Then comes the old story of the way the orange market was ruined this year by wholesale shipments of unripe fruit to San Francisco and Eastern cities in December.

The fact is there were no oranges in Southern California that were sufficiently matured to ship in December, or not enough to make any figure in the market. Half-ripe fruit was shoved off by the carload. The only well matured citrus fruit that could be found in the State during that month was produced in the northern counties, where the orange crop matured a full month sooner than it did in Southern California. But the growers in that part of the State could not resist the temptation to send out carloads of immature fruit. This proceeding had much to do with spoiling the market.

Then the condition was made much worse by large shipments of frosted oranges in January. The report is that 500 carloads of such fruit were shipped. The probability is that the shipments were much greater. It is known that in the single district of Riverside there were more than 500 carloads of oranges that were unfit for market. Much of the fruit was shipped immediately after the cold snap. It was given out that it would be destroyed. But there is reason to believe that the great amount of worthless fruit that appeared in the Eastern markets accounts for the way in which the growers turned it to account.

FACTS ABOUT GOOD ROADS.

San Diego Union: Members of the State Bureau of Highways have now traveled over 4,000 miles in their various trips through the State. They have gathered a large amount of information which should be of great importance when legislation is sought for improving the thoroughfares of California. In addition to this, they have accomplished much by arousing the interest of the people. If there be a sentimental or esthetic side of the good roads movement, however, the Commissioners have studiously kept it in the background. They are mainly occupied in presenting hard facts and figures. For example, when the commission was at Fresno recently Mr. Maude, one of the members, made a little talk in which he presented the following summary of the cost of bad roads: The value of the total farm products of the United States is placed at \$2,500,000,000. To haul these products to the depots for shipments costs each year \$900,000,000, or 40 per cent. of the entire crop. Forty per cent. of this \$900,000,000 is dead loss. That is, this hauling could be done for \$300,000,000 less if the roads were good. If the roads were good, hauling which now costs \$900,000,000 could be done for \$594,000,000. The difference is dead loss. This absolute loss, if saved and put to use, would build 39,000 miles of magnificent road each year at a cost of \$10,000 per mile.

BY A DREAMER. Colusa Sun: The several labor organizations met in convention a few days ago and adopted a series of resolutions. The paper is well written and might easily receive the indorsement of all the world. It was written, however, by some dreamer, who wrote in entire disregard to the world as it is. If mankind were perfect, if we had entered about the second decade of the millennium, it would be quite easy to fix up a code of laws for the government of mankind, but most unfortunately, there is no sign of the approach of the millennium and lawmakers must come down to man as he is. We would all like to have everything free and wages high if we could only find the fellow to put up for it. It would be the jolliest sort of fun for the Government to own and run the railroads and telegraphs and all that sort of thing, print all the money we all want, have us work as many hours as we want to work and do as we please generally, with never a care for anything. Some dreamers seem to

think they could have discounted the Almighty in making a world. He made a world in which the strong every instant subsist on the weak. Every man, every animal, with every breath, with every drink of water, with every mouthful of food, must destroy some form of life; the big fish will eat the little ones, the hawk will eat the sparrow, the man and the wolf the lamb, and, until man has an entirely different nature from what he has at present, the strong man, in intellect or in muscle, will take advantage of the weaker ones—will live at his ease while his less fortunate fellows labor. If any of us could become independent by merely saying we intend to do so, there would not be a dependent man on earth, but the individual cannot make conditions by a cry so, nor can an aggregation of men do it. The resolutions read very prettily and the dreamer who wrote them felt better when the ink got dry.

THE KENWOOD SWINDLE.

Tulare Register: The Kenwood land swindle in Sonoma County is a pathetic affair. A boomer, by paying a small sum down and mortgaging it for the balance, sold a considerable number of tracts, giving a contract for a deed, but himself failed to meet his own contracts, and a foreclosure of the mortgage he gave is depriving the settlers to whom he sold of all that they have worked for and paid for. There have been thousands of such outrages as this perpetrated in California, and a public law is that the men who inflicted such losses upon a perhaps too confiding people should not be forced to do penal service for the State they have thus wronged. Yet the forms of law have been preserved. The inscription of the mortgage on the records at the county seat was due notice of such claim, and the people were unwise to put their faith in the boomer, but if people were not unwise there would be no Kenwood swindles. The law cannot reach this man Carman, who colonized Kenwood. It may even be that he never intended to swindle anyone, but failed in his plans for want of proper business qualifications, yet that does not afford a proper extenuation for leaving confiding colonists in the lurch. The system of giving bonds for deeds of mortgaged property is all wrong, and a public law should be prevented. Public policy demands it, for every such failure as that at Kenwood hurts the entire State and is a hindrance to legitimate enterprises.

GROVE JOHNSON.

Petaluma Argus: California may well feel proud of her Representatives in Congress. They are all taking a lively interest in favor of the construction of the Nicaragua Canal by the Government, and for the use of gold and silver, and increasing the volume of the circulating medium, and increasing the revenue of the Government without issuing interest-bearing bonds. * * * Congressman Johnson has won distinction already by his able and eloquent plea for the restoration of silver as a money metal. In a recent speech he gave the Republican party some excellent advice.

We should like to see this desire for life grow; to see our young men as the graduates from our colleges and universities turning their attention to the soil, seeking the farm and the orchard and becoming familiar with the life of the country and the vast opportunities which it offers them for the acquisition of home comforts and wealth such as they can never find in the city. The professional walks of life are crowded, and our young people should be educated to accept the fact that farming is as honorable as any of the professions, and that there is as much room on the farm for the exercise of one's attainments as in any of the so-called learned professions. The educated farmer is not compelled to wrap up his knowledge in a napkin, but he can put it to practical use in the cultivation of his fields and the growing of his crops, and reap far better results than his neighbor who knows nothing of the wonder-working forces of chemistry and agricultural science.

THE GOBEL BILL.

Bakersfield Echo: It would be interesting to know if the "Examiner," "Call" or Mayor Sutro heard anything drop about the time the Kentucky Senate took a vote on the repeal of the S. P. charter? One man in five, for a purpose that will never be known, voted to take away the company's charter, and this we dare say, is a larger vote than could be secured if a same question were submitted to the people of California. During the somewhat heated discussion that preceded the vote neither of the papers above mentioned pointed out a single benefit that would result to the people of this State from the repeal of the charter. Not one. It was conceded on all sides that a repeal would put the company to some trouble and annoyance, but where or how it would reduce rates or make the road more accommodating to its patrons was not and could not be shown.

HUNTINGTON'S STATEMENT.

Stockton Mail: The remarks of C. P. Huntington before the Pacific Railroad Committee forms an interesting and instructive contribution to the history of the Central Pacific Railroad, and if they were carefully studied by the people who are demanding that the Government take from the company against the company, many of them would undoubtedly moderate their zeal, if, indeed, they might not even join those who ask that the railroad be dealt with fairly and according to sound business principles.
