NUMBER FIFTEEN. The necessity for exempting certain property from execution was recognized by the Legislature...

EXEMPT FROM EXECUTION. Section 1. Section 690 of an Act entitled "An Act to establish a Code of Civil Procedure..."

1. Chairs, tables, desks and books, to the value of \$200, belonging to the judgment debtor.

2. Necessary household, table and kitchen furniture belonging to the judgment debtor, including one sewing machine, stove, stoves and furniture...

3. The farming utensils or implements of husbandry of the judgment debtor, not exceeding in value the sum of \$1,000...

4. The tools or implements of a mechanic or artisan necessary to carry on his trade, the notarial seal, records, and office furniture of a Notary Public...

5. The cabin or dwelling of a miner, not exceeding in value the sum of \$500; also, his sluices, pipes, hose, windlass, derrick, cart, pump, or implement...

6. Two horses, two oxen, or two mules, and their harness, and one cart or wagon, one dray or truck, one cow, one hack or carriage, for one or two horses...


