

DOUBLE TRAGEDY IN WASHINGTON.

A Young Girl Shot and Killed on the Streets of Palouse.

The Murderer Then Puts an End to His Own Existence.

A Horrible Case of Poisoning Reported at Sitka, Alaska—A Saloonkeeper Sells Indians a Concoction of Whisky, Coal Oil, Lemon Juice and Alcohol—Several Dead and Others Dying.

SPOKANE (Wash.), Aug. 25.—A special to the "Spokane-Review" from Palouse, Wash., says: A terrible tragedy was enacted on Main street last night, when Frank Maupin, Jr., shot down Miss Flora James as she was returning from church, and then turned the gun on himself. In both cases death was almost instantaneous.

Young Maupin was a son of Frank Maupin, one of the pioneers of this section. Miss James came here from Cheney last fall with her widowed mother, and has since been employed at the St. Elmo Hotel. She was a prepossessing girl of 16 or 17 years. For months Maupin has been paying attention to Miss James, and was insanely jealous of her.

Last night Miss Hattie Bush, a friend of Miss James, called at the hotel and asked her to go to church with her. She consented, and the two went down Main street to a tent where services were being held. They left the tent in company with Earl Preffer, who walked up the street between them. When about two blocks away, Maupin, who was walking behind them, called to Miss James, and talked with her a moment. As she turned to see he drew a revolver and sent a bullet crashing into the base of her brain, just back of the left ear. Almost as quick as a flash the gun was placed just over his own left eye, and a second later a bullet did its work.

JUDGE LYNCH MAY PRESIDE.

Horrible Deed of a Saloonkeeper at Sitka, Alaska.

SEATTLE, Aug. 25.—News comes from Sitka by the steam collier Wilamette of a horrible case of poisoning. When the steamer left there were indications that Judge Lynch would try the culprit who did the poisoning.

Mickey McGee, a saloonkeeper at Sitka, sold several bottles of liquor to ten Indians, and they became violently sick. Just how many of them were dead when the steamer left, the passengers did not know. One said that five were dead, and another that two had died, and five others were dying. The Indians were greatly excited, as well as the population, but McGee was out on \$1,500 bail. He claims that he did not know the whisky was poisoned. He admits selling them the stuff.

The fatal concoction was a mixture of whisky, coal oil, lemon juice and alcohol. It is claimed that it was mixed to be sold as whisky, but some claim that McGee had it in for two Indians for informing on him the day before and gave them the deadly dose to get them out of the way.

HOME FOR AGED PEOPLE.

A Little Difference Between Mrs. Hollenbeck and the Trustees.

LOS ANGELES, Aug. 25.—Mrs. Hollenbeck and the Trustees for the Home for Aged People, which she built and endowed, do not interpret the various clauses in the trust deed in quite the same way, and the matter is to be determined by an equity proceeding in the Superior Court.

This suit has been brought in the name of the people by Attorney-General Fitzgerald, on the complaint of John D. Fisher, against Mrs. Hollenbeck, the Trustees and the Board of Managers. The trust deed and the by-laws are set forth, the latter providing that applicants for admission to the home must be "persons" of good moral character, not less than 60 years old, while the trust deed provides that the property conveyed is for the purpose of maintaining a home "for indigent women and homeless children."

(Continued from Seventh Page.) count of the conduct or management of such primary, except for the expenses of holding and conducting public meetings, and of printing and circulating primary election ballots, hand-bills, cards, and other papers previous to such primary election, and all advertising and all postage, expressage, telegraphing and telephoning, and of supervising the registration of voters and watching the polling or counting of votes cast at such election, and all salaries of persons employed in transacting business at office or headquarters, and necessary expense of maintaining the same, and for rent of rooms necessary for the transaction of the business of the candidate, and for necessary incidental expenses. There shall be attached to the statement herein provided for, an affidavit subscribed and sworn to by such candidate, which must be substantially in the following form: HERE IS WHAT YOU MUST SWEAR TO.

State of California, County of —, ss: I (name), having been a candidate for the office of — at the primary election held in the city, county, city and county, or other jurisdiction, of the State of California, on the — day of —, 18—, do solemnly swear that I have paid for my expenses at said primary election, and for all purposes of furthering my candidacy, directly or indirectly, within six months prior thereto, the sum of \$—, and no more, and that except as aforesaid, I have not, nor to the best of my knowledge and belief has any person, club, society, or association on my behalf, directly or indirectly, made any payment, or given promises, or offered any reward, office, employment, or valuable consideration, or incurred any liability on account of, or in respect to the conduct or management of the said election, and that I have not, directly or indirectly, promised any office or reward for any support of my candidacy prior or subsequent to said primary election.

AND I FURTHER SOLEMNLY SWEAR THAT, except as aforesaid, no money, security, or equivalent for money, has, to my knowledge or belief, been paid, advanced, given, or deposited by any one, to or in the hands of myself, or any other person for the purpose of defraying any expenses incurred on my behalf, or in aid of said primary election, or of my nomination, or on account of, or in respect to the conduct or management of the said primary election. And I further solemnly swear that I will not at any future time make, or be a party to the making, or giving of any payment, reward, office, employment, or valuable consideration for the purpose of defraying any such expenses as last mentioned, or provide, or be a party to the providing, of any money, security, or equivalent for money for the purpose of defraying any such expenses.

IF A DISCLAIMER. If the candidate wishes to avoid the responsibility of any illegal payment made by any other person in his behalf, he shall set out such illegal payment and disclaim responsibility therefor. Candidates for office to be filled by the electors of the State, or of any political division greater than a county, and for members of the Senate and Assembly, Representative in Congress, or for members of the State Board of Equalization, State Board of Railroad Commissioners, shall file their statements in the office of the Secretary of State. Candidates for all other offices shall file their statements in the office of the Clerk of the county where the primary and convention is held, and within which the duties of the office for which the candidate is nominated are to be exercised. Vouchers must be filed for all expenditures except in case of sums under five dollars.

A WARNING TO CANDIDATES. Section 35. Any candidate nominated for any public office who shall refuse or neglect to file for at least ten days such statement shall not be placed upon any ballot, but the Judge of the Superior Court of the county wherein such statement is filed, or is required to be filed, may, on the application of a candidate or a creditor thereof, allow any claim, not in excess of the maximum amount allowed by this Act, to be presented and paid after the time limited by this Act, and a statement of any sum so paid, with a certificate of its allowance, shall forthwith, after payment, be filed by the candidate in the same office as the original statement of the candidate. If the candidate, upon such application, shall show to the satisfaction of said court that there is any error or false recital in such statement or affidavit, or that the failure to make such statement or affidavit, or to present, within the designated time, a claim, otherwise just and proper, has been occasioned by the absence or illness of such candidate, or by the death of such candidate, or by such other cause as shall be shown to the satisfaction of the court, the court may, after such notice of the application as the court shall require, and on the production of such evidence of the facts stated in the application as shall be satisfactory to such court, by order, allow such statement and affidavit to be filed, or such error or false recital therein to be corrected, or such claims to be paid, as to the court seems just; and such order shall relieve the applicant from any liability or consequences under this Act in respect of the matters excused by the order. If the application is made by a creditor, the court may, under like conditions, and upon a like showing, order the claim to be paid, and the creditor shall also be entitled to his costs. The claims of one or more creditors may be united in such application, but the

No candidate of any political party or organization can have his name printed upon any ballot, to be voted for as a candidate for public office at any election in this State, unless he shall have been nominated by a convention composed of delegates chosen as provided by this Act; provided, however, that nothing in this Act shall prevent any candidate from being nominated as provided in section 1188 of the Political Code; but such nominees can have no other designation on the ballot than the word "Independent"; and provided further, that no more than one candidate shall be nominated by one petition.

THE HUNDRED FEET LIMIT. Section 37. No ticket or ballot must, on the day of a primary election, be given or delivered to or received by any person except the Inspector, or a Judge acting as Inspector, within one hundred feet of the polling place. No person must, on the day of election, hold any ticket or unfold any ballot which he intends to use in voting, within one hundred feet of the polling place; exhibit to any other person in any manner, by which the contents thereof may become known, any ticket or ballot which he intends to use in voting. No person must, on the day of election, within one hundred feet of the polling place, solicit the support or vote of any other person, nor request another person to exhibit or disclose the contents of any ticket or ballot which such other persons intend to use in voting. If at any precinct or polling place there shall be a line of persons desiring to vote, no person shall remain in such line after he has voted, or after an opportunity has been had for him to so vote, nor shall such line be in any manner delayed or hindered.

AVAST! SALOONS. Section 38. No polling place shall be held in any saloon where malt, vinous, or spirituous liquors are sold, or in any room being from, or in any manner connected with such saloon. CREDENTIALS. Section 39. Immediately upon making out the credentials of any delegates elected under this law, the Clerk shall mail to the Secretary of each political party or organization which participated in the primary, a complete list of all delegates to whom credentials shall have been given, either by himself or by the various precinct clerks as here provided, and said clerk must, in a proper book to be kept by him, record

the names of all delegates elected, with the vote received by each, specifying those to whom credentials have been given, stating when and where such credentials were issued, and whether issued by himself or by the various precinct officers as aforesaid, and if any delegate entitled to credentials shall not have received his credentials, or if he have lost the same, said clerk must, upon request, issue a new credential in such delegate, which must be stamped "Duplicate."

REGISTRAR AND CLERK. Section 40. When, at any time after the passage of this Act, there is in any county, or city and county in this State, a duly qualified and acting Registrar of Voters, then, during the period that there shall be such a duly qualified and acting Registrar of Voters, all the duties herein imposed and acts required to be done by the County Clerk of such county, or city and county, are hereby imposed and required to be done by such Registrar of Voters, in the place and stead of such County Clerk. Section 41. Within thirty days after the passage of this Act the Secretary of State shall cause 20,000 copies of this Act to be printed in pamphlet form for free distribution.

Section 42. All Acts and parts of Acts inconsistent with this Act are hereby repealed. Section 43. This Act shall take effect immediately.

BIG WHEAT FLEET. Forty-Eight Vessels Sail From Baltimore for Europe. BALTIMORE (Md.), Aug. 25.—There are now in port loading full or part cargoes of grain fourteen steamers including the Knight Bachelor, of 4,992 tons, which will take away the largest cargo of grain that has ever left Baltimore. A fleet of forty-eight ocean-going vessels is laden with full or part cargoes of grain now at sea bound from Baltimore to European ports. It is the largest number of vessels ever bound from an American port at the same time. Each vessel is carrying from 50,000 to 150,000 bushels of grain. The export record for the month has already been broken, as 5,000,000 bushels of wheat, corn and rye are now afloat for England, France, Germany, Norway, Belgium, Ireland, Scotland and Holland. All but two of the vessels sailed since August 1st. During the same period seventeen other steamers had sailed from here with large cargoes. The grain men here sustained no losses by the drop in wheat to-day. Baltimore is not a speculative market and the sales here Monday and yesterday were all on account of foreign markets for French supply. THE WEEKLY UNION—THE BEST weekly on the coast.
