streets, petitioned that the sewer pipe connecting them be lowered three feet, in order to drain off the water.

Trustee Paine said it was an important matter and he moved that the matter be referred to the Sewer Committee and Superintendent of Streets to report. So ordered.

Charles F. Donovan requested permission to withdraw his application for a saloon license at 830 N street and his request was granted.

A resolution of intention to improve the alley between N and O, Twenty-second and Twenty-third streets, with a sewer was adopted.

A communication from a San Francisco firm offering to contract with the city for a new heater at the Chief Engineer's work was referred to the Chief Engineer of the Water Works and the Water Committee.

Trustee Paine said there had been much complaint among property owners in the neighborhood of Twenty-fifth and Twenty-sixth, between N and O streets, that they could not get enough water. He moved that the four-inch pipe there be taken up by the City Tapper and taken to the cannery on Twenty-fifth street and that a six-inch pipe be put down in its place. It would take about 400 feet of pipe.

Devine feared that there would not be pipe to spare.

The motion was carried.

Trustee Paine moved that Superintendent of Streets Touhey be authorized to have Mr. De Rosa dump all his spare earth into the canal at Seventeenth street at 35 cents a cubic yard.

Trustee Devine said that the earth would have to be excavated again if the sewer should be questioned.

Trustee Paine said that according to the plans of the Surveyor the pipes will not be laid within twenty feet of the present ditch and the order of the court must be obeyed.

Trustee Devine said that statement confirmed him in his idea. He wanted to save the city's money.

Trustee Dolan said that if the board did not obey the order of the court, the members might find themselves in jail.

Trustee Kent thought the Superintendent of Streets could plow down enough dirt originally thrown out of the ditch and nearly fill it up. He so moved.

Superintendent of Streets Touhey said the city could not plow in the dirt without making the street below grade. He thought that the city would do well to buy the earth with which to fill in the ditch.

Kent's amendment was lost, and Paine's motion was carried.

Clerk Desmond reminded the board that next Monday night bids for lighting the streets would be opened and citizens should notify their respective Trustees before that time where they wish to have new lights placed.

The board then adjourned.

DOWN SOUTH.

This Will be a Hard Year for Farmers There.

State Controller E. Colgan has returned from an extended trip through the southern counties of the State made for the purpose of examining, as a member of the State Board of Equalization, property values preparatory to fixing the State rate of taxation next summer.

Controller Colgan says the outlook in the south is extremely gloomy, and that crops on non-irrigated lands will be a total failure. In portions of San Benito, Santa Cruz and other counties that are under a good system of irrigation ditches fruit and other crops promise well, but most of the southern counties are completely dried out.

Mr. Colgan is inclined to believe that the late rains will greatly benefit some of the crops in southern counties, notably that of beets, which are just coming up.

The Ways of Burglars.

A well-known detective of several years' experience has this to say of burglars: "If one were to become a professional burglar his work would be a steady and unexciting one. It is in legitimate business demands education and experience. The burglar who does several 'jobs' and eludes the officers of the law is a keen observer, a man of forethought, and one whose executive ability is unquestioned.

Apparently there was not a clew. Detectives were placed on the case and named the thieves by the method employed in getting into the store, and subsequently the thieves were convicted. Certain burglars also enter a cellar and come up through stairs, floor or roof. Others enter through keys. Others go above and come downstairs. Some break in rear and other front doors. In the robbery above referred to the two thieves had been in Troy three successive Saturday nights. They had fastened a silk thread on all entrances. Others way that if anyone entered or left the store the thread would be broken. Thus the burglars learned that the proprietor and clerks did not visit the store after closing Saturday night until Sunday. The fourth Saturday night they 'cracked' the safe. They had fastened a key on the door entering by the cellar; no suspicion would have attached itself to them.

"Even burglars have some style. People living in modest homes, unless they have large sums of money or jewelry, need not fear a visit from the professional. He is always posted on the streets and in the papers. He has also received immense impetus through the improvement of steam vessels, and the increase of the size and motive power.
