

TRUSTEES RAISE OBJECTIONS

PROPOSE TO TAKE MATTERS INTO THEIR OWN HANDS.

Enlist That Officers Shall Not be Sent Off Their Beats to Stop Gambling.

A meeting of the Board of Trustees was held last night, there being present President McKay, Trustees Brown, Devine, Dolan, Douglas, Paine and Tebbets, in accordance with the following call issued by the Mayor:

The members were a unit in accepting the suggestion embodied in the call, and a resolution setting this (Friday) afternoon apart as a half holiday to enable persons to visit the races at Agricultural Park, was unanimously adopted.

The Trustees individually expressed the hope that merchants and others employing labor would observe the order and give their employes a chance to see the races and to enjoy themselves.

The board adjourned, but immediately reconvened as a board of inquiry, and brought up the matter of the action taken by Chief of Police Dwyer in collecting his men about the entrances of places in which gaming was being conducted.

The telephone was brought into requisition and Chief Dwyer was summoned. When he arrived the board opened proceedings. He said the board desired to inquire into the recent disposition of the police force at night. He had walked home Wednesday night and saw two officers standing on the northeast corner of Sixth and J streets.

He inquired of Police Dwyer if he was collecting his men about the entrances of places in which gaming was being conducted.

"Then they gamble, just the same," ruminated Trustee Tebbets. "Are they selling pools yet?" inquired Trustee Dolan.

"I suppose so," replied Chief Dwyer. "I don't know if it be true or not, but I don't know." "If the Mayor," said Trustee Paine, "has given the Chief orders to close the games, it is probably his duty to do so, but what this board wants is protection for the city, and if one officer can't close the games on his beat it is time for the board to act."

"There is no necessity," said Trustee Devine, "to have three men hanging around one gambling place when they arrest neither the proprietor nor the frequenters, and merely stand around and exhibit themselves. I think Trustee Paine put it just about right."

"I move," said Trustee Douglas, "that Chief Dwyer be instructed to place his officers on their respective beats and keep them there."

DEATH OF HENRY L. BUCKLEY YESTERDAY.

Twice District Attorney of the County, Twice Police Judge and Also City Attorney.

Henry L. Buckley, the well known lawyer and Judge, passed away at the Sisters' Hospital at an early hour yesterday morning, having been seriously ill only since Tuesday night.

Judge Buckley had hosts of friends in Sacramento, and was accredited with being one of the best criminal lawyers in the city. He was of a sensitive and modest disposition, and in the trial of a case never resorted to the abuse of either the man he was prosecuting or the attorney on the other side.

Judge Buckley was born in Boston in 1855, and was nearly 45 years of age when death claimed him. About six weeks ago he caught a severe cold, which finally caused congestion of the lungs resulting in his death.

Henry L. Buckley was educated in the public schools in this city, and began his law career in the motive power and machinery department of the Southern Pacific Company's shops, under A. J. Stevens. He subsequently served as a clerk in the office of City Superintendent of Schools, then held by Judge A. C. Hinkson. He subsequently held the office of Armstrong & Hinkson, and was admitted to the bar.

In March, 1878, Judge Buckley was elected City Attorney, when he made an enviable record. In 1879 he was elected District Attorney, and under that position, held the office for three years. In the fall of 1884 he was again elected to the office, serving two years.

In 1887 Judge Buckley was elected Police Judge, which position he held for two terms—four years. He was Assistant District Attorney during District Attorney Ryan's first term, and in 1892 was again elected Police Judge, holding until under the new charter the position was abolished.

It is understood that a meeting of the Sacramento County Bar Association will be held to-day for the purpose of adopting resolutions of respect to the memory of the deceased.

Judge Buckley's relatives in this State are his father, P. J. Buckley, his brother, John J. Buckley, and his sister, Miss Mamie Buckley, all of this city, and a married sister, Mrs. J. F. McCracken, of San Francisco. The funeral will be private and will probably take place to-morrow.
