

# CONDITIONS IN THE PHILIPPINES.

## General Otis Sends a Cable to the War Department

## Regarding the Situation at Manila and Other Points in Islands.

## Conditions at Manila Much Improved and No Trouble Anticipated With the Insurgents—Story of a Naval Battle Pronounced Absurd by Both Navy and War Departments.

WASHINGTON, Oct. 20.—General Otis has cabled the War Department quite a long dispatch regarding the conditions in Manila and the Philippines. The dispatch contains matters which bear on the negotiations pending in Paris and will be cabled to the United States Peace Commissioners to-day. The dispatch says the situation at Manila has improved and General Otis says he does not anticipate any trouble with the insurgents. The War Department to-day posted the following bulletin:

"The situation in Luzon is somewhat improved. The influence of Filipinos of education and property not desiring independent Government, but hostile to Spain, gaining ascendancy in revolutionary councils. An promising nothing but enforcing the law. Complications seriously affect inter-island commerce and diminish revenue. Affairs progressing favorably, though sick report increasing, owing mostly to carelessness of enlisted men. Health of officers good. Condition of city and environs for quartering troops improving. Fever decreasing. Intestinal troubles about the same. Many slight ailments. Smallpox apparently arrested. During the month 28 deaths, 8 smallpox, 8 typhoid fever, 5 malarial and intestinal complaints, 3 accidental." General Otis cabled considerable more than the above, but the department does not deem it advisable to make the other portions of the dispatch public because of its bearing upon the peace negotiations. It contains suggestions by General Otis regarding the disposition of the Philippines, and also information about the insurgents.

### STORY OF A NAVAL BATTLE SCOUTED.

WASHINGTON, Oct. 20.—The sensational Spanish report of a naval battle between Admiral Dewey's vessels and the insurgent navy in the Philippines is received with absolute incredulity in both the Navy and War Departments. If there has been any recent action Admiral Dewey has failed to mention it, and neither General Otis nor United States Consul Wildman have regarded it as worthy of notice.

It is believed at the Navy Department that the Spanish authorities refer to the seizure of the little steamer Abbey by the McCulloch, September 23d last. The steamer was of American register, though formerly known as the *Passie*. It was reported to Admiral Dewey that she was bringing arms and supplies of war to the insurgents. He sent the McCulloch to stop this movement, but when the cutter found the Abbey in Batangas Bay the vessel had landed her cargo of arms, and the insurgents refused to give them up. Thereupon the Abbey was seized and taken by the McCulloch to Manila. This affair could not be dignified with the name of a naval engagement, and Admiral Dewey in reporting the seizure to the Navy Department made little of it.

It is just possible that there have been some similar incidents not deemed worthy of report in the islands of Cebu or Panay, as it has reported that some insurgent vessels have been carrying arms to spread the insurrection in those islands, and Dewey would have repressed them. 

Navy Department show that it is absurd to speak of an insurgent navy seriously, for the entire force consists of a few schooners and one or two little coasting steamers, altogether not being a match for the least of the vessels under Dewey's command.

The explanation of the Admiral's interference with these vessels in their operations is a desire on his part to maintain the status quo in the Philippines pending the conclusion of the Peace Commission's work in Paris. It is said here that it is not surprising that the Spanish Cabinet they are sure to meet in Madrid when the Philippines come under consideration before the Peace Commission, that the United States forces have never been able to take possession of and hold this territory outside of Manila proper. Under the rules of international law, such a point is not entitled to serious consideration in determining what disposition should be made of the territory.

### ANARCHY IN SOUTHERN PHILIPPINES.

MANILA, Oct. 20.—The United States cruiser *Boston* and the collier *Nero* which, on October 5th, were ordered to proceed to Zamboanga, in connection with the recent disturbances at and near Peñon, have arrived at Amoy, on the island of that name, in the province of Fo Kien, opposite Formosa, the former seaport, and the latter with her cargo afloat.

Reports have reached here of a terrible state of anarchy in the southern Philippines. The Spaniards there are cooped up in the principal towns. The Americans continue capturing the rebel vessels as they arrive at Cavite. Two have been captured this week.

### PUT A BULLET INTO HIS BRAIN.

#### An Unknown Man Commits Suicide at Omaha.

OMAHA, Oct. 20.—An unknown man has committed suicide at the Public Library here under mysterious circumstances.

Everything points to the fact that he had secreted himself in the building the night before with the intention of robbing the priceless collection of coins of the Byron Reed donation. When detected and capture confronted him, he coolly placed a revolver to his temple and fired a bullet into his brain. When the watchman rushed upon the scene the man was dead.

The body appears to be that of a man of culture. There is nothing by which it might be identified. He was evidently a Russian, from some slight markings on the clothes would seem to indicate that he was a nobleman. The police believe the man was a visitor at the exposition who possessed technical knowledge, and was, perhaps, a collector of rare coins himself. Recognizing the value of the treasure, he separated from him only by the glass case, he determined to seize it, and for that purpose visited the library in the evening and secreted himself ready for the work. Early in the morning the watchman noticed the burglar alarms leading to the Reed collection ring violently. An investigation followed, and the man with the weapon exploded and the man fell dead in the hall in front of the watchman.

The door leading to the Reed collection had been tampered with. This is the fourth time burglars have attempted to rob this collection. The thousands of gold coins of all nations it includes represents a large fortune, to which is added the value of the coins as rare specimens and complete sets of the specie of all nations.

The coroner is investigating the case. The suicide was a large, fine looking man, seven feet tall, with a prominent nose, building previously and the police can learn nothing concerning him. He was probably 45 years old, but there was nothing in his pockets to indicate his identity.

The name John Schmidt was found written on the margin of a small map of Europe found in one of his pockets. The map was torn from a Russian geography. A pair of sun glasses, the case of which bore the label "Riga, Russia," was also found. On the corner of a pocket handkerchief in red silk were embroidered the letters "J. K. P."

The dead man, from the cut of his clothing, had not been in this country long. From the appearance of his wearing apparel and his general appearance he was above the ordinary station of life.

### AT THE TRAPS.

#### Result of Yesterday's Live-Bird Shooting at Nashville.

NASHVILLE, Oct. 20.—Rain and high wind interfered with the shooting match to-day at Bell Meade Gun Club grounds. Summary:

First event, miss and out, at seven live birds, thirty-four enlisted—Budd, Hollowell, Rattle, Gay, Falls, Fulford, Hase, Young, Gilbert, Lyons, Quincy, Dunaway, Grab, Anthony, Gerst, Legler, Norton, McMurry and Culmton tied, each killing seven birds.

Second event, William Gerst handicap, fifteen live birds, handicap from twenty-five to thirty-one yards, 815 entrance, thirty-nine entries—Fanning, Anthony, Facchetti, Gilbert, Quincy, DeBowen and Rattle tied with fifteen birds each and divided the money.

Third event, ten live birds, miss and out—Fanning, Norton, Acklen, McMurry, Gay, Young, Gilbert, Budd and Helkes tied, killing ten birds each.

Special, twenty live birds, miss and out—Rattle, Gilbert, Budd, Anthony, Helkes and Dubray tied, killing twenty birds each.

### Positions of Warships During Destruction of Cervera's Fleet.

WASHINGTON, Oct. 20.—The report of the Wainwright board, convened for the purpose of determining the positions and courses of the ships engaged in the action at Santiago July 3d, was made public to-day. It shows in detail the positions at various times of the vessels engaged in the fight.

The tracings on charts which accompany the report show that the Spanish vessels sailed on courses not more than three-tenths of a mile apart until the *Quendo* ran ashore. Then the *Vizcaya* veered out to sea, and the *Colon* kept nearer the shore, their courses being about seven-tenths of a mile apart.

Up to the time the *Quendo* went ashore the Iowa, Indiana, Oregon and Texas sailed on courses within three-tenths of a mile of each other, the Iowa being the nearest and the Texas the farthest from the Spanish vessels.

The Brooklyn's course was from three-tenths to one-half of a mile outside that of the Texas. The swing to the right which the Brooklyn made at the beginning of the engagement shows an oval four-tenths of a mile across. She crossed the courses of the Texas, Oregon and Indiana twice while making the turn, but before these vessels had gone over them.

The course of the New York after passing Morro was nearer the shore than any other United States vessel except the Gloucester and a mile behind where the *Quendo* turned to run ashore she passed inside the courses of the Spanish ships. Ten miles west of the *Vizcaya* disaster she crossed the

### DISASTROUS TYPHOONS.

#### FEARFUL HAVOC WROUGHT IN THE ORIENT.

Hundreds of Villages Swept Away and Thousands of People Drowned.

VANCOUVER, Oct. 20.—Disastrous typhoons, sand storms and floods have caused a fearful loss of life and property in the Orient.

In the district watered by the river Feng in Japan, hundreds of villages have been swept away, and 3,000 people have been drowned.

Another report says 250 towns are under water. Thousands of refugees are flocking to the cities.

The Ishikari River has also overflowed, drowning over 1,000 people. Seven prefectures were destroyed.

In a terrible typhoon off Formosa, happening the same time as the floods, great damage to shipping was done. At Ternani eight junks were wrecked and a hundred lives lost. Twelve junks were driven to sea and lost. The steamer *Kensui Maru* was piled upon shore. Among the ships wrecked was the American bark *Comet*. The ship was abandoned and crew saved. The French steamer *Holow* is wrecked on the beach near Amoy. The German steamer *Trinidad*, formerly of the Cunard line, was abandoned in the open sea.

Homebound passengers state that they passed through twenty miles of abandoned wrecks, chiefly Chinese junks. The loss of life must have been enormous.

### TEXAS STORM.

#### Does a Vast Amount of Damage in Southern Part of State.

ST. LOUIS, Oct. 20.—A special to the "Republic" from Houston, Tex., says: The electric and wind storm which swept over Texas last night was very severe in Southern Texas. Damage to cotton is enormous. At Deer Park, twenty miles from Houston, the residence of G. F. Adams was demolished. S. A. J. Cook was crushed to death. At Pasadena the residence of John Stout was turned over and badly wrecked. Several people were injured.

The wind was so high in Missouri City, thirty-five miles east, that it blew a number of freight cars from the siding out on the main track. The California express dashed into the cars at full speed. The engine turned over, instantly killing George Johnson of Sen Antonio, the engineer, and scalding the fireman and injuring the head brakeman. None of the passengers were badly hurt.

### Yellow Fever Situation.

JACKSON (Miss.), Oct. 20.—The yellow fever reports for to-day were encouraging, the effect of the recent cold weather is improving the situation. Jackson had only one case to-day and no deaths. The thermometer is in the fifties. The official report of the State Board of Health for the past twenty-four hours shows only seven new cases and two deaths for the balance of the State, as compared with twenty-five cases and four deaths yesterday.

### Spanish Officers to be Paroled.

WASHINGTON, Oct. 20.—The Secretary of War sent a cable message to-night to Major General Otis, in command of the American forces at Manila, authorizing him to parole twenty Spanish officers now in his custody as prisoners of war. Application for the parole of these officers was made by the Spanish authorities to General Otis and he referred the question to the War Department at Washington. It is understood that the prisoners desire to return to Spain.

### Reception to General Shafter.

LIMA (Ohio), Oct. 20.—Fully 10,000 people participated in the reception of General Shafter to-day. He arrived from Chicago at 1:30 p. m., and a big parade was at once formed. Lunch was served and a public meeting held at the Opera-house.
