



of race and climate. And we may remind our kindly foreign critic, that if English art students go to Paris to acquire the technical training and instruction which they cannot find here, our painters, by virtue of their intellectual power and original genius, have repeatedly supplied French artists with the inspiration that was their strength. Thus it was from Constable that the men of 1830 derived the original impulse which led to the brilliant development of landscape art by the masters of the school of Fontainebleau, while, in more recent years, Monet and his comrades, Pissarro and Sisley, found the secret of Impressionist landscape painting in Turner's gorgeous visions, and the mystic dreams of Watts and Burne-Jones have largely helped to foster the growth of a new school of idealistic painting in France at the present time. In spite of these radical differences, however, English art, we repeat, has during the last sixty years won for itself a high place in the estimation of the world, and has at the same time given signs of renewed strength and vitality at home. We need only look back to the state of art in the early years of the Queen's reign to realize how remarkable a change has taken place in this respect.

OUR SOLDIERS AT MANILA.

CONDITION OF THE CALIFORNIA REGIMENT.

Lieutenant Colonel Martin's Report to the Adjutant General of the State.

Lieutenant Colonel Walter S. Martin, Aide-de-Camp on the Governor's Staff, N. G. C., writes from Manila to Adjutant General Peeler of the National Guard of California as follows:

"Sir: I send herewith a report on the California troops in Manila. By General Orders No. 5, dated August 12, 1898, I was directed to report monthly to the Adjutant General's headquarters in this city, and to make special reports regarding the condition and other matters as may be of interest of the California United States volunteers. Although I have not had these orders repeated since the change of administration, I send this report, and shall forward another shortly, more general in scope.

Manila, P. I., January 22, 1899.

To the Adjutant General National Guard of California—Sir: I think it is unnecessary for me to review the work done by the California volunteers, from their landing, and during the taking of Manila. They made themselves conspicuous by gallantry, bravery and their position always in the front, and by good discipline and good spirit.

In the taking of the city, Colonel Smith was able to lead them in first, second and third assaults, and when he appeared before the citadel of Manila, there, in an assault upon the walls he lost some of his men. After various duties and transfers, the regiment was finally attached as present, to the First Brigade of the First Division in San Francisco on route 11, Grand total 1,223.

Since last report (one month) eight men discharged for disability; three on order and one died of disease. As to the question of returning home, I think that the officers and men would at any time be glad to receive summons. Their families, business interests and a natural desire to exchange the inconveniences which they meet with here, for the pleasures of home, would explain this. I doubt if any interrogation would elicit a request to return. The health quarters and living, at present, are as good as it is possible to expect, and the prospect of winning new glories and a chance to fight has quelled all idea and talk of returning. However, the hot season is coming on, and it will be hard with our men in camp, or in the field, and therefore, if any action is proposed in this matter, it should be settled immediately, so as to avoid the unfavorable conditions here, and the discomfort attendant upon travel on the transports in hot weather and during the typhoon season.

These points, I think, cover every matter of interest to your office, and I shall be glad to give you any further information or explanation that you may require.

In relation to the Battery of Heavy Artillery, I have had less opportunity of seeing it and thus obtaining information concerning it. Most of it arrived late in November, and has since formed part of the guard of Cavite. It is quiet and orderly there, and the health of these troops, I believe, is good. Under the head of unavoidable shortcomings are (a) incompleteness of the individual mess-kits; (b) having some men equipped with black belts and McKeever's cartridge belts; (c) absence of gun slings in some cases; (d) haversacks and canteens not marked, as enjoined in par. 279 A. R., and these are designated unmarked because it is understood that requisitions have been duly submitted looking to correction.

The pieces of Companies A, H, F and C were found in a particularly satisfactory condition and among these C is perhaps the best preserved. From the point of merit; this refers to relative merit upon the field; there are fewer causes for criticism among these companies than in the others; but upon the whole the condition of the pieces in the regiment was very satisfactory.

In the matter of keeping books, returns, records, etc., this regiment stands very high. This statement briefly summarized the ascertained condition of things.

In few cases did Captains or their officers examine into the cases of candidates for the doctor's attention at sick call and before sending the men to the doctor.

The laundry work of this command has largely been in a manner highly satisfactory. This is due to the enterprise of the men in this respect.

The course pursued in this respect is an important matter which will be taken as a guide for others.

There are two exchanges styled Canteens in this regiment, one for each quarter where the battalions are located. At present one exchange council supervises both, and as a result the Captains in one quarter are not represented thereon. It is believed that a council organized so as to secure this would be more satisfactory. The rules governing exchanges at posts in time of peace cannot be too strictly construed, and applied to troops in campaign.

This regiment is prepared to take the field now, although it would be at a considerable disadvantage on account of the shortage in full equipments mentioned, a deficiency which the proper regional officers, it is reported, have tried and are now laboring to remedy.

There is a true military spirit pervading the regiment through the commissioned ranks, the influence of which is highly salutary. It is a genuine pleasure to see the effects of it; the decorous, orderly, efficient and military manner in which the affairs of the regiment are conducted.

From the brigade report of December 31st, I have made the following extracts concerning the strength and condition of the California volunteers:

Present—Officers—Special duty 8, on duty 36, staff 9, sick 1. Total 45. Enlisted Men—Special duty 123, on duty 975, sick 74, arrest 32. Total 1,204.

Absent and Present—(Officers)—Detached services 2, on leave 2. Grand total 4 (Enlisted Men)—On leave 2, in San Francisco or on route 11, Grand total 1,223.

Since last report (one month) eight men discharged for disability; three on order and one died of disease. As to the question of returning home, I think that the officers and men would at any time be glad to receive summons. Their families, business interests and a natural desire to exchange the inconveniences which they meet with here, for the pleasures of home, would explain this.
