S. B. 1036, Joyce—To amend Section 501 of the Civil Code of the State of California, relating to street railroad cars; read third time and passed, 24 to 1.

S. B. 171, Nutt—To amend Section 1 of an Act fixing jurisdiction, and providing compensation for Justices of the Peace in cities and towns, approved March 9, 1883; read third time and passed, 21 to 5.

S. B. 128, Dickinson—To amend Sections 537, 538 and 539 of the Code of Civil Procedure, relating to attachments; read third time and passed, 23 to 4. Braunhart gave notice of a motion to reconsider.
