

FELL AMONG THIEVES.

CHARLES MARTIN KNOCKED DOWN AND ROBBED.

He Identifies Five Men Arrested by the Police as His Assaultants.

About 5 o'clock last evening Charles Martin, who lives with his wife and step-daughters at the Mansion House on Seventh street, between I and J, was knocked down and robbed of \$40 in the back room of Luchemeyer's saloon on the north side of J street, between Second and Third, and nearest the latter.

At 4:30 o'clock Martin left home with \$40 in his pocket. He was drinking, and his wife tried to induce him to leave his wealth with her, but without success. On Wednesday Martin, who had been employed on the American River, received a month's pay, and it was his earnings that were taken.

According to Martin's story he went into the saloon and treated a few of the dozen men who had gathered in the back room. One of them started in to pick a row with Martin, but the latter, who was not looking for trouble, tried to conciliate him by reminding him that he had done the "right thing"; that he could pay his way, and that he had \$45 in his pocket to pay it with.

The mention of the money evidently excited the cupid of the thugs, for one of them promptly knocked Martin down, while another of the party rifled his pockets, and then the gang scattered.

Acting Chief of Police Ash was soon on the ground, but could at first learn nothing from the barkeeper, who said he was at the bar and did not know what was going on in the back room. He subsequently pointed out five or six men whom he said were in the back room when the robbery was committed, and these Chief Ash and Officers Douglas and M. A. Fisher gathered in.

When searched at the police station they gave their names as follows: Frank Murphy and J. S. Murphy (brothers), Frank Martin, Harry Scott, George Clifton and John Reynolds. Clifton was the only one of the half dozen arrested who had any considerable sum of money on his person. The men are all strangers in this city, having been here only a day or two. Martin was confronted with the men later in the evening at the station and positively identified five of them, pointing out the man who struck him and the one who went through his pockets.

Charles Martin will be confronted with the suspects this morning, if so be, and it remains to be seen whether or not he can recognize among them his assailants. The police believe that the money secured from Martin that divided up among the crowd present. About two months ago Martin was arrested on a charge of representing himself to be an agent of the Natoma Vineyard Company, and in that capacity attempting to hire men to go to work picking grapes. On these representations he succeeded in getting drinks from a number of men who wanted employment, but the offense was so slight that Justice Anderson discharged him.

Later in the evening Officer Butler arrested a man at Second and L streets who gave his name as William Sanders, and Martin identified him as the man who first struck him and knocked him down.


