Hats of all shapes and sizes, from the lofty bell-crown and immense mane-fringe, to the equality, rimless and magnificent top-hats, are sported on this occasion. A few have whiskers and mustaches, but most are devoid of these appendages. Some that look as if every tailor in the country had struck out an original idea for himself, and which designate the wearer's nationality, vary with more expression than many of the owner's faces, may also be seen. Here the clerk, rushing himself, read—"and executed amid shouts of approval." Rushing from the Terminus with a wild scream, the unhappy man immediately emigrated to Texas, leaving his fate to be an awful warning to all nervous telegraphic clerks.—*Comic Bostonian.*

TREASURE NOT TROVE.
Mr. Randall (not) Trove, a boy of Spanish descent, was made to locate a lot of Spanish dollars, which were lately dug up on Barron Island, near their city, and forthwith a crowd assembled, armed with spades and pick-axes. Nothing more valuable than cast-iron shells was discovered.
PERILOUS EXPEDITION.
From the Prairie du Chien Patriot, of July 26th, we learn that Mr. A. Randall, of the United States Geological Corps, accompanied by his assistant, Maj. M. DeGree, reached this place in safety after a few days' journey, the publication of the paper. They had been traversing the North-western wilds since May last, on a geological, zoological and botanical tour, and will report to government the result of their observations. When near the Ganguk river, a tributary of the St. Peters, he encountered a wild war party by a large party of the Sisseton Sioux Indians, by signs, ordered him to proceed South, which he was forced to do, leaving many valuable collections.
Mr. Randall speaks in the highest terms of the country which he traversed, for beauty, agricultural capacity and mineral resources. Coal was found for 200 miles on the Des Moines, and from indications, heavy deposits of iron ore are believed to exist. Gypsum (plaster) in abundance, forming cliffs for miles, was encountered. This proves of immense value to the west, as the first instance of its being known in the great Valley of the Mississippi. Limestone that makes a superior hydraulic lime, exists in abundance. Limestone, suitable for lime, exists suitable for bricks; rocks suitable for polishing, for grindstones, whetstones, and for building purposes. Coal was found in abundance along the Des Moines river.
The country over which Mr. Randall passed is the Des Moines, which river he explored from its mouth to its source; also, the Chateaufort Prairie, the western portion of the Iowa prairie. Throughout his whole explorations, there is a great abundance of water power, and with few exceptions, plenty of timber. Mr. Randall reports that the Fox Indians are much disaffected with their new homes, and he thinks the government is likely to have trouble with them. The Fox Indians were anxious to get information of any parties of the Sioux Indians. Bitter animosities exist between the two tribes. Mr. Randall in his route underwent many hardships and perils.
WAVERER RETURNED.
The young man, 18 years of age, son of James H. Haines, of Burham, Me., Senator for Waldo county, who wandered off from his home in a state of insanity, returned after being gone six days, almost exhausted, and without knowing what had happened to him. He finally recovered his senses. Hundreds of the neighbors were in search of him.
KILLED BY A BULL.
A man named Elias Lewis, had his neck run through by the horn of a bull, near New Haven, Conn., and is since dead. The horn just entered below the ear, and came out on the opposite side.
DEATH OF THE OLDEST ISRAELITE.
The last Adam (Gen. Banner) announces the death of Mr. Daniel Hale, of Franklin county, in that State, who died on the 21st of July last, in the one hundred and ninety-third year of his age, leaving on his death, a son 76 years of age, a grand-daughter 44 years of age, and a great-grand-daughter 22 years old.
HARBORERS' DISAPPOINTMENT.
A son of Mr. Burr, of Philadelphia, has been missing two years. The child, four years old, Mr. Burr always supposed that his son had been carried off by a crew of harborers, and hearing of one in Western Pennsylvania, said to be in possession of a boy resembling his own, he went in pursuit. The boy proved not to be his. He telegraphed the fact to his wife, but the telegraph read:—"My own child will be home on Wednesday." Mr. Burr returned home, and his wife flew to embrace her long lost child, when the mistake was discovered. The child had not been found.
ANOTHER LIFE LOST AT CONEY ISLAND, N. Y.
A man, while bathing at Coney Island, ventured out too far, and was carried away by the strong current. By a paper, it appears his name was A. Laughlin.
WOMEN CAN PROTECT THEMSELVES.
A few nights ago, at White Plains, N. Y., an attempt was made to rob the house of a lady residing there, named Mrs. Crosby. Two previous attempts had been made, in the first of which a young girl residing in the house was brutally injured, and the second was frustrated by a dog, but this time the same young lady, procuring a revolver, and preserving a shadow pass, fired, but with what effect has only guessed by the marks of blood left behind.
